

## MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON APRIL 14, 2014

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Jack Porter.

The meeting was called to order and roll call: Windle Hardy, Mike Lennier, and Jack Porter.

Mike Lennier made a motion to approve the minutes of the April 7, 2014 meeting. It was seconded by Jack Porter. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

Windle Hardy made a motion to approve the following blanket purchase order numbers 143737 to 143742. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

GCEMA/Fire Report: Dale Thompson informed the board about the O'Ryan Disaster System application and could be added to the commissioners I-Pads. Mr. Thompson explained how the application works and he will be working with the CERT Team on this as well. The CERT Team is meeting this Thursday at 6:30 PM to take applications. Fire Report: It has calmed down and been quiet. Mr. Thompson informed the board that he would be attending training next week with the Homeland Security.

There was no action on the burn ban for Grady County.

Update: IT Coordinator, Russell Nichols informed the board that the antennas for District 1 & 2 are being tested, some problems with them so may change and get different ones and need to know which trucks you want the antennas on. Also, the I-pads are ready for installation and let him know and would like to get this done soon.

At 9:45 AM-Windle Hardy made a motion to accept the bids for Driving Piles for Bridges on CR-1250 for District #1. The bid made by Rent-A-Crane of Wheatland, OK 73097 Cost price: \$14,000 or if delivered within 30 days-\$13,500.00. It was seconded by Jack Porter. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter. Other bidder: The Railroad Yard of Stillwater, OK cost price: \$29,000.00 or \$35,000.00 if delivered within 30 days

There was no action on the conducting a 3-D Geophysical Survey across Lot 1 Block 2 University Park & Blocks 5, 21, & 31 of Sparks Addition to the City of Chickasha.

There was no action on declaring surplus for the OSU Extension Office or disposing of equipment for OSU Extension Office.

Jack Porter made a motion to accept the application for permits from EOG Resources Inc. permits to cross with a natural gas pipeline, a county road or highway of Section 31-T6N-R7W & Section 6-T5N-R7W, Section 27 & 34-T6N-R8W. There was no action on the Interlocal Agreement between the City of Tuttle and District #1.

Jack Porter made a motion to approve to remove a portion of Minor Collection Route 2646C, beginning SH 17 and extending north approximately 5.25 miles to EW 149.8 from a

roadway that does not exist. It was seconded by Windle Hardy. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

Windle Hardy made a motion to approve the transfers and appropriations for the following departments: Election Board Secretary & County Wide 911 Calling. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.
