

MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON APRIL 20, 2015

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Ralph Beard.

The meeting was called to order and roll call: Windle Hardy, Mike Lennier, and Ralph Beard.

Mike Lennier made a motion to approve the minutes of the April 13, 2015 meeting. It was seconded by Windle Hardy. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Ralph Beard.

Windle Hardy made a motion to approve the following blanket purchase order numbers 154218 to 154275. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Ralph Beard.

GCEMA/Fire Report: There was no report from Dale Thompson or Paulette Nicholas. There was no update from IT, E911, or Safety Progress.

Windle Hardy made a motion to approve the claim of Grady County to the Oklahoma Tax Commission-Ad Valorem Division-Loss of Revenue to Grady County and the School Districts therein due to the Additional Homestead Exemptions allowed for the year **2014** -this claim is made in accordance with the provisions of 62 O.S.
