MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON APRIL 21, 2014

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Jack Porter.

The meeting was called to order and roll call: Windle Hardy-absent, Mike Lennier, and Jack Porter.

Jack Porter made a motion to amend the minutes of the April 14, 2014 meeting-to clarify the motion of the changes to the GCCJA (Grady County Criminal Justice Authority Board)-the chairman for the board of commissioners will serve on the GCCJA board and make the board a 5-member board as done previously and not a 7-member board, and to remove the last two appointed members from the board-Carl Alexander and Damon Logue.
