MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON AUGUST 17, 2015

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Ralph Beard.

There was no report from GCEMA, Fire Report, update from It, E911, or Safety Progress.

At 9:30 AM-Windle Hardy made a motion to accept the bids for Labor and Equipment only to complete Salt Creek Bridge at County Road 1250. Windle Hardy made a motion to approve the monthly reports for the following county offices: Assessor & Health Department. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Ralph Beard.

Be it resolved by the Board of the Grady County Commissioners to review and approve claims generated by the Grady County governing bodies during the month of August and before, and authorize or deny payment of such claims.
