MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON AUGUST 18, 2014

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Jack Porter.

The meeting was called to order and roll call: Windle Hardy, Mike Lennier, and Jack Porter.

Mike Lennier made a motion to approve the minutes of the August 11, 2014. It was seconded by Jack Porter. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

Windle Hardy made a motion to approve the following blanket purchase order numbers 150788 to 150873 & 150877. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

GCEMA/Fire Report: There was no report from Mr. Thompson (attending the southwest conference). Ms. Shoemake submitted an email regarding the safe room project and funding from the Grady County Home Finance.

There was no action on the burn ban or update from It, E911, or Safety Progress.

Windle Hardy made a motion to approve the Interlocal Agreement between the City of Tuttle and Grady County for REAP Grant applications and Storm Sirens Installation. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

Mike Lennier made a motion to approve the Extension Services Agreement between OSU, U. S. Department of Agriculture, and Grady County for the period of July 1, 2014 through June 30, 2015. It was seconded by Jack Porter. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

OSU Executive Director, Susan Routh Introduced the New OSU Ag Educator-Brad Secreau, Ms. Routh stated that Mr. Secreau has served in the Air Force, is from Wisconsin, and formerly ran a dairy farm and stated Mr. Secreau will be a great asset to our County. Mr. Secreau introduced himself and is looking forward to working at the OSU Extension Office.

Jack Porter made a motion to deny the Tort Claim #14-020 from the Personal Representative of the Randal Douglas Smith Estate-wrongful death -Notice of Claim. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

Mike Lennier made a motion to approve a Proposition to allow the question of the Imposition of a countywide sales tax to benefit the Grady County Fire Departments to go to a vote of the citizens of Grady County during the November 2014 General Election. It would be a one-eighth of one percent (0.125%) sales tax levied by the Grady County, Oklahoma Board of County Commissioners for a period of Ten (10) years upon the Gross Receipts and Gross Proceeds derived from all Sales within Grady County, Oklahoma upon which a Consumer's Sales Tax is Levied by the State. It was seconded by Jack Porter. NAY: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

Jack Porter made a motion to approve the agreement between Grady County and Canadian County Juvenile Detention Center for detention services. It was seconded by Windle Hardy. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

Mike Lennier made a motion to approve the bid on all of Lot 2 of Block 1 of the Rock Island Addition. It was seconded by Windle Hardy. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter. (Location of the property: 1405 South 1st Street, Chickasha, OK)

At 9:25 AM-Mike Lennier made a motion to accept the bids for Renovation of the Treasurer's Office. The bid made by Gary Steelman Construction of Amber, OK for the price of \$85,500.00.
