

## MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON JULY 28, 2014

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Jack Porter.

The meeting was called to order and roll call: Windle Hardy, Mike Lennier, and Jack Porter.

Mike Lennier made a motion to approve the minutes of the July 21, 2014 meeting. It was seconded by Jack Porter. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

Windle Hardy made a motion to approve the following blanket purchase order numbers 150532 to 150539, 150541, & 150543. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.

GCEMA/ Fire Report: Paulette Nicholas informed the board that Dale Thompson was at Rush Springs informing them the procedures to be in compliance with NIMS. Ms. Nicholas stated a few fires, some medical calls, and 20% chance of rain this week.

There was no action on the burn ban or update for the IT, E911, or Safety Progress.

Windle Hardy made a motion to approve the payment of the maintenance agreement for the 911 Back Up Calls Equipment for the Sheriff's Department from the General Fund. It was seconded by Jack Porter. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Jack Porter.
