

## MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON MARCH 31, 2014

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Jack Porter.

The meeting was called to order and roll call: Windle Hardy, Mike Lennier was absent, Rodney Holden Deputy Commissioner representing District #2, and Jack Porter.

Windle Hardy made a motion to approve the minutes of the March 24, 2014 meeting. It was seconded by Jack Porter. AYE: Windle Hardy, AYE: Rodney Holden, and AYE: Jack Porter.

Windle Hardy made a motion to approve the following blanket purchase order numbers 143593 to 143608. It was seconded by Jack Porter. AYE: Windle Hardy, AYE: Rodney Holden, and AYE: Jack Porter.

GCEMA/Fire Report: Dale Thompson reported a 20% chance of rain on Wednesday this week with possible hail and wind. Mr. Thompson stated some small grass fires only.

There was no action on the burn ban or update report from the IT, E911, or Safety Progress.
