MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON OCTOBER 27, 2014

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Jack Porter.

The meeting was called to order and roll call: Windle Hardy and Jack Porter. Mike Lennier was absent.

Windle Hardy made a motion to approve the minutes of the October 20, 2014 meeting. It was seconded by Jack Porter. AYE: Windle Hardy and AYE: Jack Porter.

Windle Hardy made a motion to approve the following blanket purchase order numbers 151839 to 151857 & 151860. It was seconded by Jack Porter. AYE: Windle Hardy and AYE: Jack Porter.

GCEMA/Fire Report: Paulette Nicholas informed the board that the Chili Cook-Off was successful and went very well. Fire report: There were some assisted medical calls and some small fires, but overall a quiet week-slight chance for rain and cool front will be coming.

Windle Hardy made a motion to approve the acceptance of a donated bus from the Grady County Criminal Justice Authority to the Grady County Emergency Management Agency. It was seconded by Jack Porter. At 9:15 AM-Windle Hardy made a motion to request for bids for 6-month bids for road oils for all districts. It was seconded by Jack Porter. AYE: Windle Hardy and AYE: Jack Porter.

Jack Porter made a motion to approve and accept the Geophysical Permit from (Tidelands Geophysical)- BlueLineGeo to conduct a 3D Seismic Survey-Section 29-T3N-R6W in Grady County after an addendum to the permit-No vibratory equipment used in right-ofway.
