MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON FEBRUARY 1, 2016

The Board of the Grady County Commissioners met on this day for a regularly scheduled with the following board members: Mike Lennier, Windle Hardy, and Ralph Beard.

The meeting was called to order and roll call: Mike Lennier, Windle Hardy, and Ralph Beard.

Windle Hardy made a motion to approve the minutes of the January 25, 2016 meeting. It was seconded by Ralph Beard. AYE: Mike Lennier, AYE: Windle Hardy, and AYE: Ralph Beard.

Mike Lennier made a motion to approve the following blanket purchase order numbers 163415 to 163437. It was seconded by Windle Hardy. AYE: Mike Lennier, AYE: Windle Hardy, and AYE: Ralph Beard:

GCEMA/Fire Report: Dale Thompson informed the board that Chickasaw Telecommunications will be checking the tornado sirens in the Ninnekah area, reminded the board of the pipeline safety meeting next week, and stated 43 sets of bunker gear that was damaged in the recent oil rig fire has been sent off to check damages, cleaned and see if they can be used if not have to replace. Fire report: Several fires this past week-(4)-Bridge Creek area, Winter Creek Golf & Country Club, one near Hawkins Church, and South of Highway 19.

Mike Lennier made a motion to approve the removal of Danielle Herron as receiver officer from the Emergency Management account and appoint Amanda Wilkerson to the following SALESTX-GFD-Fire Stations, GCEMA LEPC-2, GCEMA-Grant LEPC-3, GCEMA-DHS-2, GCEMA-DHS-3, GCHFA-SRP-2 accounts, & EOP Grant account. Ralph Beard made a motion to approve the declaration of surplus on out of compliance Turn Out Gear to be disposed of in a manner benefiting the GCFD. It was seconded by Mike Lennier. (Christie Kern of the Grady County Fire Department informed the board that the out of compliance turn out gear can't be sold or reissued due to safety matters-the Black Helmet Co. would take the old gear and give a \$50 gift card to help purchase bags for the firefighters).

There was no update report for the Safety Progress.

Mike Lennier made a motion to approve the increase for the monthly rent on the USDA rental space-the increase-\$9.16/USF, \$38,994.12 a year/ -\$3249.51 a month. It was seconded by Windle Hardy. AYE: Mike Lennier, AYE: Windle Hardy, and AYE: Ralph Beard.(The rental space is being enlarged and renovated).
