

MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON JANUARY 4, 2016

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Mike Lennier, and Ralph Beard.

Mike Lennier made a motion to approve the minutes of the December 21, 2015 and the special meeting on December 29, 2015. It was seconded by Windle Hardy. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Ralph Beard.

Windle Hardy made a motion to approve the following blanket purchase order numbers 162994 to 163009. It was seconded by Mike Lennier. AYE: Windle Hardy, AYE: Mike Lennier, and AYE: Ralph Beard.

Recognition of Darryal Young's retirement: The board recognized and thanked Darryal Young for his service to Grady County. The board congratulated Mr. Young and submitted a plaque of his service to him.

GCEMA/Fire Report: Dale Thompson gave a weather report for the week stating a possibility of rain/snow Tuesday night into Wednesday. Mr. Thompson also submitted a brochure from SBA (Small Business Administration) for assistance available to Oklahoma Private Nonprofit Organizations. Mr. Thompson informed the board that Grady County did not receive any REAP grants and requested to apply for a CDBG grant and the board agreed. Fire report: Mr. Thompson stated there was a few accidents mostly due to the recent winter storm and stated most of the power outages had gotten electricity and discussed the warming shelters.

There was no update from E911, IT, or Safety Progress.
