The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Mike Lennier, Windle Hardy, and Ralph Beard.

The meeting was called to order and roll call: Mike Lennier, Windle Hardy, and Ralph Beard.

Windle Hardy made a motion to approve the minutes of the December 28, 2016 meeting. It was seconded by Ralph Beard. AYE: Mike Lennier, AYE: Windle Hardy, and AYE: Ralph Beard.

Mike Lennier made a motion to approve the following blanket purchase order numbers 173189 to 173205 & 173211. It was seconded by Windle Hardy. AYE: Mike Lennier, AYE: Windle Hardy, and AYE: Ralph Beard.

GCEMA/Fire report: Dale Thompson thanked Mr. Hardy for the work done at the repeater near Minco and reported that Tuttle has placed a Ham Radio at the site. Mr. Thompson informed the board that he was working with Red Cross on the generators that are located at the Emergency Shelters when disasters happen, meeting with the local response coordinator to go over the MIPS plan, read an email from Richard Pettijohn from Grady Memorial Hospital stating the main water feed to GMH would be shut down Friday, January 6, and stated chance of 1" to 2" of snow later part of this week. Fire report: Christie Kern stated a busy new year weekend-several fires-one near the Acme Fire Station and helped other fire departments-McClain County, Blanchard, and Chickasha.

Safety Director, George Manning checked on the radar detectors, will be doing the Census Report, need to work on the Bomb Plan, working on the Labor reports, discussed the health cards for CDL drivers-(will get the location ready for them-most likely will be at the hospital), informed the board on the traffic alert signs-very expensive-\$15,234.60 each, will be ordering SAS workstations, and will be working on the disaster plans for each barn district.

Mike Lennier made a motion to approve the draw request from Grady Memorial Hospital to CMS Willowbrook Construction-construction costs. It was seconded by Windle Hardy.
