**AN APPLICATION SHALL BE MADE FOR EACH COUNTY ROAD CROSSING**

**Petitioner must call the appropriate District Barn before the permit is issued to inform the District of the scope of work proposed, and if the Commissioner deems it necessary an onsite pre-work conference may be scheduled. Fee of \$1500.00 per Application for Permit unless waived by the Board of Commissioners. Fee must be received before application is approved.**

1. Petitioner shall protect and save harmless Grady County from any cost, change, expense, action or suit by reason of the construction, operation, maintenance or the existence of said utilities - such as, pipeline's, water, Electric, or gas/oil pipelines: Petitioner will provide Grady County with the name of their liability Insurance carrier.

2. All roadway crossings for utilities shall be made by boring and cased: or extra heavy walled piping, 1/3 to 1/2 thicker than the pipe in the pipeline or utilities.

3. Petitioner shall restore said County roads to their original condition by repairing any damages caused by the construction operation, maintenance or existence of its utilities: all graveled roads shall be re-graveled with like materials.

4. Petitioner shall construct said utilities across the County roadway at a minimum depth of 48" below the surface of the profile of the barrow ditch: 12" of dirt on pipe, 4' x 4' square, 12" thick of concrete and remainder filled with dirt.

**5. Petitioner shall before completion, and after concrete work, notify County Commissioner's District office for final inspection.**

**Failure to notify the County for final inspection will result in the applicant having to dig up, and expose, at their cost, their utility to meet full compliance with the permit.**

6. The utilities will be marked by signs with the following information:

a. The name of the Company    b. The type of Line    c. The depth of the line    d. The phone number

7. All signs to be placed on all Grady County maintained roadways where utilities cross. Signs to be legible, red background with black lettering.

8. Companies making application for permit will supply Grady County with maps showing where lines cross county roads. These maps will be updated as additions or deletions are made.

**PARALLEL TRENCHING MUST BE APPROVED BY THE COMMISSIONER OF SAID DISTRICT BEFORE ISSUING OF PERMIT.**  
**ANY TRENCH MUST BE 5 FEET FROM SURFACE OF ROAD. ANY DEVIATION MUST BE APPROVED.**

Applicant agrees to keep said utilities and all appurtenances thereto maintained at all times in a state of good repair, to install the said utilities with as little interference as is possible to the flow of traffic along said road, and to remove said utilities at its own expense when such removal is necessary for the repair, maintenance or widening of said road or highway.

Applicant further agrees to comply with all of the rules and regulations of the Board of Grady County Commissioners of Grady county, Oklahoma, and the laws of the State of Oklahoma that pertain to the laying or the maintenance of utilities along or across Grady County roads or highways.
