

MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON APRIL 2, 2018

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Ralph Beard, and Kirk Painter.

The meeting was called to order and roll call: Windle Hardy, Ralph Beard, and Kirk Painter. The meeting was opened with the "Pledge of Allegiance"

Windle Hardy made a motion to approve the minutes of the March 26, 2018 meeting. It was seconded by Ralph Beard. AYE: Windle Hardy, AYE: Ralph Beard, and Kirk Painter.

Windle Hardy made a motion to approve the following blanket purchase order numbers 184919-184933. It was seconded by Ralph Beard. AYE: Windle Hardy, AYE: Ralph Beard, and AYE: Kirk Painter.

The Board recognized Donna Wright as Purchasing Agent, Sydney Richardson as Assistant Purchasing Agent, and Catherine King as Land Records Supervisor.

GCEMA/Fire Report: Dale Thompson was not present but had reported to the commissioners that there were 330 applicants for Safe Rooms and those they would start the next process soon. Kim Duke reported that the total amount of calls in the year 2017 was 798 from 12 departments; she also reported that they are preparing for the new building and that she had turned in all the paperwork for the REC grant and was looking forward to hopefully receiving that at the REC banquet.

No Action made on an update from the Safety Director, the draw request for the Grady Memorial Hospital or the Courthouse Security Vestibule.
