

MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON AUGUST 20, 2018

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Ralph Beard, and Kirk Painter.

The meeting was called to order and roll call: Windle Hardy, Ralph Beard, and Kirk Painter.

The meeting was opened with the "Pledge of Allegiance"

Windle Hardy made a motion regarding the resolution calling a special election and authorizing the issuance of an Election Proclamation for the McClain County and Grady County Emergency Medical Services District. It was seconded by Kirk Painter. Stuart England of Floyd Law Firm presented to the Board and provided information. The Newcastle district wants to create a new fire district. They already have land they have purchased for a building but want a vote of the people to have a bond. The Advalorem Tax in this district would be assessed up to 3 mills; they are hoping it will not go over one mill. Mr. England informed the board that both counties have to be involved because of boundaries between the two counties. The Oklahoma Constitution makes us have a joint resolution with McClain County. Mr. England also explained that it was put on the ballot back in April but was voted down. AYE: Windle Hardy, AYE: Ralph Beard, and AYE: Kirk Painter.

GCEMA/Fire Report: Dale Thompson reported that Steve Kelley from ASCOG had contacted him and wanted to know if Grady County was going to turn in a REAP application again this year. The Commissioners told Dale he could proceed with the application. Dale wanted to recognize Amanda Wilkerson for receiving the Professional Emergency Manager Award. Dale told the board that the issue with the railroad crossing had been taken care of and that he had contacted district 2 to take down their signs. He also told the board that the HMPG grant reimbursement should be expected in September. Kim Duke informed the Board of Commissioners that there was a board meeting Tuesday night at 7:00pm. Grady County Rural Fire Departments were represented by Perry Wenzel and Larry Hayes who appeared at the request of the Commissioners. The Fire Departments were notified that Grady County would no longer process reimbursements. It was advised that blanket purchase orders be used in place of the reimbursements. The State Auditor's office provided the information which led to the decision to end reimbursements.

No report from the Safety Director.
