

MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON JANUARY 22, 2018

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Ralph Beard, and Kirk Painter.

The meeting was called to order and roll call: Windle Hardy, Ralph Beard, and Kirk Painter. The meeting was opened with the "Pledge of Allegiance" and "Prayer."

Windle Hardy made a motion to approve the minutes after the amendment to EFT Remittance from FEMA for District #1 in the amount of \$3728.00, which went to First National Bank & Trust Co and should have went to Liberty National Bank. Mr. Thompson discussed the Weatherization Program and stated once it got started has really gone well. County Clerk, Sharon Shoemaker informed the board that the Grady County Home Finance Authority brought their records to her office to store (they are working with Dale on the Weatherization Program). Mr. Thompson informed the board that his office is hosting the SW Community Drill this week, on March 29 & 30th-Cameo -with DEQ Program on hazard materials that will report on oil well sites in the county, and submitted a newsletter from Oklahoma Emergency Management-called EM Report, and reported several fires in Grady County with a slim chance of rain. Fire report: Kim Duke informed the board that there were several small fires-very fortunate it wasn't worse with the weather conditions. Ms. Duke stated the US Forestry had stage equipment and went to some of the fires-very helpful.

There was no action on the burn ban, update from safety director, draw requests from GMH or Courthouse Security Vestibule.

Introduction of the New Ag Educator for the OSU Extension Office: Liz Taylor introduced the new Ag Educator-Shiann Burns. Ms. Burns told the board she was from Madill-has her bachelor's and got her Masters from New Mexico college-background-farm/ranch and cattle.
