

MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON SEPTEMBER 24, 2018

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Windle Hardy, Ralph Beard, and Kirk Painter.

The meeting was called to order and roll call: Windle Hardy, Ralph Beard, and Kirk Painter.

The meeting was opened with the "Pledge of Allegiance"

Dale also informed the Board of Commissioners that FEMA was going to be conducting a nationwide test. Perry Wenzel was here to report to the Commissioners in Kim Duke's absence. He told the board about a few accidents and reported the progress on the new building.

Safety Director Report: George Manning reported to the Board of Commissioners that he was getting the report filled out on accidents; he also stated that he would be out of the office for 3 to 6 weeks for medical issues.

There were no applications for tin horn permits.
