## MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON SEPTEMBER 21, 2020

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Ralph Beard, Kirk Painter and Mike Walker.

The meeting was called to order and roll call: Ralph Beard, Kirk Painter, and Mike Walker.

The meeting was opened with the "Pledge of Allegiance"

He reported to the board that as of Sunday there are 876 cases and 10 deaths in Grady County. Dale Stated that Grady County has moved its status to the color Orange.

GCEMA/Fire Report/Safety Director: Dale Thompson informed the board that he has installed the radio into the dive unit. He spoke to the board about surplusing some unused inventory and putting into an auction. Kim Duke said she may have things that need to go to an auction. The Commissioners said they would let them know when and if there would be one. Kim told them that the Fire Board meeting on Tuesday did not have a quorum and she requested some PO approvals. Bobby Cantu reported that he had two reportable motor vehicle accidents. K&M Safety Solutions has completed the annual fire extinguisher inspection for District 3 and will be conducting District 1 inspection on September 25, 2020. The hot water tank issues we had at last year's inspection at the USDA Building, Sheriff's and DA's Building has been resolved. The ladder on the DA complex that has been installed and would be getting the cage around it soon. Bobby stated that he needed new tires for his pickup and would like to get them installed soon. In closing his report, he told the board that he had a conference call with FEMA later today and the radon level in the Sheriff's basement was at a safe range.
