## MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON December 7, 2020

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Ralph Beard and Kirk Painter; Mike Walker was absent.

The meeting was called to order and roll call: Ralph Beard and Kirk Painter; Mike Walker was absent.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the November 30, 2020 meeting. It was seconded by Ralph Beard. AYE: Ralph Beard and Kirk Painter.

Dale Thompson spoke to the board about the status of COVID-19 in regards of the threat to Grady County public safety COVID-19 (Coronavirus) posed. He reported to the board that as of Sunday there are 279 active cases in Grady County.

GCEMA/Fire Report/Safety Director: Dale Thompson reported to the board that he moved into his new office, and that he was currently in the process of helping the Election Board with their move. He also stated he would be having training next week. Kim Duke had PO requests and informed the board the Fire Board meeting is December 15th. Bobby Cantu reported that there was one reportable injury last week. He told the board he completed the Court Clerk and Courthouse Security Vestibule's safety meeting this week, he also informed the board he would conduct District #3 safety meeting this week. He stated he had the 2021 Drug and Alcohol Testing policy handbook, and it was in the process of being printed. He stated the radon in the basement in the new DA building was high and we may need to get a ventilation system and a door to the basement. Ralph Beard told Bobby Cantu to look into it.

Ralph Beard made a motion to table the administration and procedure of the FMCSA (Federal Motor Carrier Safety Administration) Drug and Alcohol Clearinghouse. It was seconded by Kirk Painter. AYE: Ralph Beard and Kirk Painter.

No draw request for Grady Memorial Hospital.

Ralph Beard made a motion to approve the Declaration of Surplus of a 1989 Ford F350 for Ninnekah Fire Station, VIN # 1FDKF38G3KNB63706; a 1984 AM General for Alex Fire Station, VIN # NLOG31C52305543; a 1993 Ford L8000 for Naples Fire Station, VIN # 1FDYW82E6PVA12106 in accordance with 19 O.S. §§ 339, & 421 thru 421.2, for the Grady County Fire Department. It was seconded by Kirk Painter. AYE: Ralph Beard and Kirk Painter.

Kirk Painter made a motion to approve the bid from Greg Petty Used Cars for \$10,873.00 the selling of the damaged cab and chassis from the Friend Fire Station. (second bidder was Glen McConnell for \$4,500.00) It was seconded by Ralph Beard. AYE: Ralph Beard and Kirk Painter.
