MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON January 19, 2021

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter. Ralph Beard was absent.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, Ralph Beard was absent.

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the January 11, 2021 meeting. It was seconded by Kirk Painter. AYE: Mike Walker and Kirk Painter.

Dale Thompson spoke to the board about the status of COVID-19 in regards of the threat to Grady County public safety COVID-19 (Coronavirus) posed. He reported to the board that as of Monday there are 280 active cases and 46 deaths in Grady County.

GCEMA/Fire Report/Safety Director: Dale Thompson reported that Emergency Management and Election Board have put in more security measures. Dale gave the Commissioners a quote for electrical work. He told them about the Storm Spotting online class on February 16, 2021 and the LEPC meeting was cancelled and that he would be looking into zoom meetings. Kim Duke was present and told the board there was a meeting Monday night with the Fire Board, she said there were six new applicants on the agenda. Bobby Cantu reported to the board that there was one reportable injury last week. Bobby will be conducting the Corporation Commission fuel leak tank inspection with all three district barns, the monthly fire extinguisher inspection for all the county facilities and the District #2 monthly safety meeting. The door frame for the Courthouse is scheduled to be installed Tuesday February 2nd and he will make the weekly conference call with FEMA PDM Benneh. The radon level in the basement of the DA's building is being checked weekly and will be addressed with the Commissioners after a month.

No draw request for Grady Memorial Hospital.
