MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON February 1, 2021

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, Ralph Beard.

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the January 25, 2021 meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Dale Thompson spoke to the board about the status of COVID-19 in regards of the threat to Grady County public safety COVID-19 (Coronavirus) posed. He reported to the board that there has been a total of 5,219 cases and 58 deaths in Grady County. Dale told the board that we are still currently ranked 14th in the state for COVID cases and we have administered 377,000 vaccines at this time.

GCEMA/Fire Report/Safety Director: Dale Thompson reported to the Commissioners that the Burn Sites 90-day permit would expire if not renewed. The Emergency Management purchased Zoom for the LEPC meetings they are required to have. Dale told the Commissioners that they passed the State Department Assessment on the Passports and the total of passports he did last year were 217; not counting renewals. Dale asked the Commissioners to sign the 1st quarter EMPG grant. Kim Duke handed out the minutes to the Board and told them about one correction. Bobby Cantu reported that there were no reportable injuries last week in Grady County. Bobby told the Board that he completed the 2020 OK 300A Forms, summary of work-related injuries & illnesses; he also received the Certificate of Training Award on Site Protection Awareness. Bobby told the Commissioners about 22nd Century coming tomorrow to install the fire door & frame, & he will be doing a weekly conference call with FEMA PDM Benneh. The radon level in the basement of the courthouse falls in the safe range but the DA building is on a 60-day waiting period.

No draw request for Grady Memorial Hospital.
