MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON February 22, 2021

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, Ralph Beard.

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the February 8, 2021 meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Dale Thompson spoke to the board about the status of COVID-19 in regards of the threat to Grady County public safety COVID-19 (Coronavirus) posed. He reported to the board that there has been a decrease in the number of cases, hospitalizations, and deaths in Grady County. Mr. Spellman was present and reported they were currently contacting vulnerable patients to come in and receive the vaccine. He stated that everyone needed to get the vaccine before the virus mutated more. He also informed the board that Johnson and Johnson are developing a vaccine that would require only one dose, and should be ready soon.

GCEMA/Fire Report/Safety Director: Dale Thompson reported to the Commissioners that the President had approved the Oklahoma Emergency Declaration. He also stated that he received notification that the 911 addressing program that he had applied for, was approved. It is a \$88,000.00 reimbursement Grant that covers 75%. Kim Duke informed the board that the Fire Board Meeting was cancelled Tuesday. She also had PO requests. Bobby Cantu stated that there were no reportable accidents last week. He had to reschedule District #1 and #2 quarterly safety meetings to this week, and had to put a hold on the FEMA Conference call with Benneh until March 3rd. He will be conducting the monthly Corporation Commission fuel leak tank inspection for all three districts as well as monthly fire extinguisher inspections for all County facilities. Lastly, he noted that the radon level in the DA's basement was at 6.10 which is still above the safe range on 4.00.
