Minutes of the County Commissioners Regular meeting held on January 3, 2022

The Board of the Grady County Commissioners met on this day for an regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, and Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, and Ralph Beard

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to appoint Ralph Beard as Chairman for the Grady County Board of Commissioners for the Calendar Year 2022. It was seconded by Ralph Beard. Ralph Beard made a motion to appoint Kirk Painter as Vice-Chairman for the Grady County Board of Commissioners for the Calendar Year 2022 it was seconded by Kirk Painter AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Kirk Painter made a motion to approve the minutes of the December 27, 2021 regular meeting. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Kirk Painter made a motion to approve the plat map called Timber Trails and the road would not be maintained by the County. It was seconded by Mike Walker. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Ralph Beard made a motion to approve the plan of action of paying for and processing the Drug & Alcohol Clearinghouse for CDL drivers, by having Bobby Cantu pay for District 1, Kirk Painter pay for District 2, and Ralph Beard pay for District 3 fees with their credit cards. Bobby stated that the State Auditor's office and the District Attorney's office has approved the reimbursement procedure of these payments. It was seconded by Kirk Painter. Kirk Painter made a motion to approve the 2022 Drug and Alcohol Testing Policy. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Mike Walker made a motion to approve to modify the County's COVID policy to align with the Centers for Disease Control's (CDC) recent guidelines change as it relates to employees infected with the disease and/or exposed to someone with it. It was seconded by Ralph Beard. AYE: Ralph Beard, Mike Walker. NO: Kirk Painter.

GCEMA/Fire Report/Safety Director: Dale Thompson told the Board that the weather would warm up, then get cold again. He stated that we received more moisture than expected although it would not give the County enough relief from the drought. Kim Duke stated that there is a Fire Board meeting on February 21st. She also had requisition requests. Bobby Cantu informed the Board that they would be removing the beds from the old jail on the 17th of February and that he would volunteer his time to help get this process finished so they could move to the next step of the renovation of the jail.

Dale Thompson informed the Board that there had been no change to the drought conditions and recommended that the Board continue the Burn Ban for another 7 days. Ralph Beard made a motion to approve the action to implement a burn ban for Grady County. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Kirk Painter made a motion to approve the bid from Great Journey West, LLC in the amount of \$39,938.10 for jury chairs for Courtroom 3 – Judge Young. (No other bidders). It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Transfer of Funds – Highway to Resale. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Audience Participation: Bruce Anthony was in attendance and showed the Board where an individual had put a gate up over a County maintained road, he was concerned because there were several entities (water department, county road workers, and land owners) that were not given access at this time. Commissioner Beard stated that he would look into it.

Erin Glass with Workforce was in attendance and wanted to let the Commissioner's know that they could provide them with temporary workers for 520 hours, then they could decide if they wanted to keep that employee or not. She also told the Board that they took care of the payroil and the workman's comp on the temporary employees for the 520 hours.

Kean Spellman informed the Board that he had been asked by Southern Plains to extend a transfer agreement with Grady Memorial. He then learned that Southern Plains did not comply with the law in their current construction of a surgery center, they also failed to apply for, submit data to your staff, or obtain in advance the legal approval to construct this center. Mr. Spellman has requested that the County takes steps to enforce the law and to have the District Attorney look into this matter.

Kirk Painter made a motion to adjourn. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.
