Minutes of the County Commissioners Regular meeting held on August 23, 2021

The Board of the Grady County Commissioners met on this day for an regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, and Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, and Ralph Beard

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the amended minutes of the August 9, 2021 regular meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve the minutes of the August 16, 2021 regular meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

GCEMA/Fire Report/Safety Director: Dale Thompson informed the Commissioners that he assisted the City of Chickasha last week on the Blue Algae in Shannon Springs Park. Dale said they brought in a fire department tanker to help push some of the Algae out into Conco Creek to help with the cleanup. Dale stated that they participated in the State 911 Web EOC Drill, there were 40 County Emergency Managers and 19 Municipalities that were involved. They do this twice a year to check the system and make sure it doesn't get overloaded. He will be having a booth at the Grady County Fair for public outreach and will be handing out preparedness information. He also received an EFT payment from the Department of Emergency Management for \$2,226.71. It is a reimbursement of Amanda's deployment to a hurricane relief effort in 2018. He asked the Board which account he should put this in and they told him General. He told Commissioner Beard that he had an update on the FEMA money that he had been working on for District #3. Dale reminded the Board to keep everyone hydrated in this heat, he said that it is going to be hot and humid this week. Kim Duke gave the Board the minutes and financial reports from the Fire Board meeting on Tuesday the 17th. She also had Requisitions that needed signed. Bobby Cantu informed the Board that there were no reportable injuries last week. Bobby said that he had completed the safety meeting with the Treasurer's office and is working on the Emergency Evacuation plans for the District Attorneys office, Sheriff's Building, and the USDA/OSU Extension Building. He spoke with the Board about the Basement Courtroom, they told him to go forward with getting the Courtroom renovated and he told them that he was still working on a small leak. Bobby said he would be working on the monthly Corporation Commission Fuel Leak Tank Inspections for all three county barns, and the monthly Fire Extinguisher Inspection for all Grady County facilities. Bobby stated that he had two vehicle accidents he went to this weekend.

Dale Thompson reported to the Board that the COVID cases were still going up. There are 15,490 cases in the state from August the 8th through the 14th. There are 82 deaths in the state and as of last Friday there are 107 cases in Grady County.

Ralph Beard made a motion to approve Emergency Management to apply for a Local Community Grant from the Walmart Foundation for Gatorade and Water. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve Emergency Management to apply for an OK-EMPG FY 21 Subgrant. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve of adding Dale Thompson as the Requisition for the following Requestioning Departments: Acme Station 8201, Alex Station 8202, Bailey Station 8203, Bradley Station 8204, Cox City Station 8205, Farwell Station 8206, Friend Station 8207, Harold Station 8208, Naples Station 8209, Ninnekah Station 8210 Pioneer Station 8211, and Pocasset Station 8212. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

No Action on the American Rescue Plan Act Money.

Chief David Macy from Bridge Creek Fire Department came to speak to the Board about the American Rescue Plan Act. They would like to purchase new Cardiac Resuscitation equipment for their fire station. Chief Macy stated that the ones that they have are not compatible to what the ambulance service uses and in an emergency situation it takes too much time to switch the critical patient to another piece of equipment. It would be very helpful in heart related situations to have the most advanced equipment. He said that the equipment they have is usable and could be redistributed in other entities in the County. Commissioner Beard told him that he would be sending it to our consultant for them to review and would get back with them if this would be a purchase that we could make with this ARPA money.

No draw request from the Grady Memorial Hospital.
