Minutes of the County Commissioners Regular meeting held on August 30, 2021

The Board of the Grady County Commissioners met on this day for an regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, and Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, and Ralph Beard

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the August 23, 2021 regular meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

GCEMA/Fire Report/Safety Director: Dale Thompson informed the Commissioners that Emergency Management and the Grady County Fire Department had a booth at the Grady County Fair to encourage public awareness and he felt there was a good turnout. He also stated that he would be working on the paperwork for the EMPG and REAP grants this week. Kim Duke had requisition requests. Bobby Cantu reported that Grady County had one reportable injury last week. Bobby stated that the permit for the Courthouse elevator has been reissued and the X-ray machine annual inspection has been completed. Bobby gave the Board an update on the electrical status on the 3rd floor, courtroom basement, and the grinder and control panel for the Courthouse. Bobby stated that he went out on two vehicle accident calls this weekend.

Dale Thompson reported to the Board that there are 232 new COVID cases and 133 deaths altogether in Grady County. There is a 33.19 % vaccination rate at this time. As of yesterday, there are 3,338 new cases in the state. Dale stated that the Courthouse had been fumigated on Friday.

Ralph Beard gave the update on the American Rescue Plan Act Money. He told the Board that he spoke with our hired Lawyer, David Floyd on Friday, and that he suggested putting an application on the website. There would be a deadline to applications of November 1, 2021 for the first phase. Then Mr. Floyd would let Commissioner Beard know which one of the projects would qualify for the grant money. The Commissioners would have to approve which applicants would receive the money and then the next round could start. Ralph Beard stated that the second part of the American Rescue money will be given to the County in September.

No draw request from the Grady Memorial Hospital.

Mr. Corey Merritt citizen from Tuttle spoke to the Commissioners about Cemetery Road and how dangerous it is with all the traffic. Mike Walker told him that he had checked the road and he felt like the traffic flow in that area had increased due to the construction detouring from Frisco Road and when they finish this road the traffic should decrease on Cemetery Road. Mr. Merritt felt that putting stop signs in would slow people down. There was an issue of the bus having to turn around on that road. Mike Walker disagreed, he said he felt like putting stop signs in places that there has never been a stop sign could potentially cause a wreck. Mike Walker said he would speak to the school superintendent about the bus turn around. The Commissioner told Mr. Merritt that he would continue to monitor this situation. No action was taken.

DEQ & Rural District #6 project for the American Rescue Plan was acknowledged and given to Ralph Beard to submit to Floyd Law Firm for review.

New Business: Ms. Locke asked the Assistant District Attorney for his opinion on the credit card issue. The issue was brought to the Commissioners attention on July 6th; a citizen was concerned that the offices in the Courthouse was charging fees to use a credit/debit card for transactions in the Courthouse. The Assistant District Attorney researched this issue and obtained an opinion from the State Senator and from the State Auditor. The Assistant District Attorney found that there was no problem with the current procedure. As the payment and fee is taken by the credit card company then the payment portion owed to the County is paid to the County from the credit card company. Ms. Locke then asked if it was allowable for a county department to pay for the customers service fee, the Assistant District Attorney said no, the County cannot only receive the service fee payment nor can the County pay for the service fee. Kirk Painter said that there had been numerous calls from OMMA applicants. He has contacted the State Fire Marshall on this issue. He also has spoken to the Code Enforcer and he wants the County to stop signing the applications and give them a Certificate of Compliance letter instead. Kirk Painter shared the letter that the Muskogee Commissioners has been giving out to applicants. The Assistant District Attorney said he would look into the matter.
