Minutes of the County Commissioners Regular meeting held on August 9, 2021

The Board of the Grady County Commissioners met on this day for an regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, and Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, and Ralph Beard

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the August 2, 2021 regular meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

GCEMA/Fire Report/Safety Director: Dale Thompson informed the Board that he had a meeting with the Southwest Coordinator and the new Chickasha Emergency Management Director. He completed the NIMS compliance certification for 2021-2022. He also informed the Board that the County would have to have a single audit this year for the CARES Grant. He had the Board sign a request to allow Amanda Wilkerson to get on the EM Grant Portal as well as a request for the 1st quarter EMPG Grant payment. Kim Duke informed the Board that the Grady County Fire Department Board meetings had been moved to the Fairgrounds, she also had PO requests. Bobby Cantu reported that there were no reportable Injury/MVA. He has completed the quarterly safety meetings for the following offices: District 1, District 3, Court Clerk, and the Election Board; and will be working towards completing the other offices. He asked if he could have one employee from each of the barns come help him move some cabinets at the Courthouse this Wednesday. Mike Walker stated that he wouldn't have anyone available, Kirk Painter and Ralph Beard stated they would send an employee each. Bobby thanked District 2 for the help with cutting a pipe at the Courthouse parking lot and filling it back in with concrete.

No draw request from the Grady Memorial Hospital.

Dale Thompson presented the Board with a map indicating the Covid levels in the state, stating that Grady County was at Orange as of last week. Dale informed the Board that approximately 28.1 percent per 1,000 cases of Covid were the Delta Variant. However, he is having a hard time getting up to date information from the Health Department as they are still about a week behind on statistics. He stated the largest age group for Covid cases is still the 18–36-year-old range and about 96 percent of people getting COVID are not vaccinated. Dale Thompson also asked the Board what the protocol would be for time off for employee's that had the opportunity to be vaccinated and had not gotten it, without a medical reason. Robin Burton stated that she had informed her employees that they would have to use their sick leave. Dale then asked how we would handle time off for employees that had been exposed from people at work. He stated he just wanted us to have a plan of action. Mike Walker stated it would be at the official's discretion. Kirk Painter stated that an employee would have to provide a letter from a doctor if they had not been vaccinated stating why they did not get the vaccine. Otherwise, they would need to use their sick leave for time taken off for COVID.

Mike Walker made a motion to approve the release agreement for TIF overpayment with the City of Chickasha. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve yearly Hyper-Reach Emergency Notification System; with Sheriff's E-911 account paying \$7,000.00 and General Government paying the remaining \$7,000.00 for a total of \$14,000.00. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve the yearly update of the County Emergency Operations Plan. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve the Disposal of a Frame MTD Toolbox, Tulsa Winch on truck mount, Fiberglass water tank, Holland 5th wheel plate (air slide), and a Holland 5th wheel plate (manual slide) for the Friend Fire Station in accordance with 19 O.S. §§ 339, & 421 thru 421.2. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

No action was taken on forming an agreement with the Grady County Conservation District.

Charles then informed the Board of his opinion of the contract drafted by Floyd and Driver PLLC, he stated that he advised the Board not to sign it. He has concerns with the lack of contingencies in the contract, and the term clause doesn't have language which would pro rate the County back. He stated that he would get in contact with David Floyd himself to come address these issues and draft a new contract.
