MINUTES OF THE COUNTY COMMISSIONERS MEETING HELD ON March 15, 2021

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, Ralph Beard.

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the March 8, 2021 meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Dale Thompson spoke to the board about the status of COVID-19 in regards of the threat to Grady County public safety COVID-19 (Coronavirus) posed. Dale reported that there are 215 active cases and 80 deaths in Grady County. Dale told the Commissioners that Grady County had turned to yellow level on the Oklahoma State Department of Health's alert map.

GCEMA/Fire Report/Safety Director: Dale Thompson reported to the Commissioners that there is 70% chance of rain on Tuesday. He informed Commissioner Beard that he would be changing the Ice Storm Assessment from a Small Project to a Large Project due to the amount of damage. He told the Commissioners the Vaccination Site is on schedule again for this Friday. He also had PO requests. Kim Duke updated the Commissioners that the board meeting would be Tuesday night at 7:00 p.m. Kim informed them that the 2020 run reports have been completed and she had a PO request. Bobby Cantu informed the Commissioners that the county had no reportable injuries last week. Bobby told them that he would be conducting a new hire employee safety orientation for District #2 and a conference call to PDM for FEMA Benneh. Bobby discussed the doors in the courthouse need to be brought up to code by using magnets to hold them open and explained how they would shut in case of a fire. Bobby brought to the attention of the board again his concern about the Radon level in the basement of the District Attorney building being so high, Commissioner Walker told him he would speak to the DA and address his concern.
