Minutes of the County Commissioners Regular meeting held on March 22, 2021

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter. Ralph Beard was late.

The meeting was called to order and roll call: Mike Walker, Kirk Painter.

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the March 15, 2021 meeting. It was seconded by Kirk Painter. AYE: Mike Walker and Kirk Painter.

Debra Humphreys with the Chickasha Senior Nutrition Center gave a presentation to the Board about the use of Senior Citizens Sales Tax. She gave a packet of information to the Board and told them that the Senior Citizen Board felt they should fix the old Community Center's issues. Ms. Humphrey's was questioning the status of how that would affect the Center's Tax Exemption. Mr. Siphers, A.D.A. told her he did not have answers for her and that it would be best if she spoke to a Tax Attorney for questions dealing with Tax Exempt Laws. Ms. Humphreys was also concerned about bidding the building construction and the Board and A.D.A. agreed that she would have to follow bidding laws.

Dale Thompson spoke to the board about the status of COVID-19 in regards of the threat to Grady County public safety COVID-19 (Coronavirus) posed. Dale reported that there are 209 active cases and 81 deaths in Grady County. Dale told the Commissioners that he was needing the numbers of how many Grady County employees needed the vaccination due to they had opened up some time slots at the hospital.

GCEMA/Fire Report/Safety Director: Dale Thompson reported to the Commissioners that the LEPC meeting would be a Zoom meeting this month, it will be held on March 31, 2021. Dale told he would be picking up more PPE from Lawton and distributing it to schools this week and he had a PO request. Kim Duke gave the Board information on the meeting and financials from the meeting. She also had PO requests. Bobby Cantu reported to the Commissioners that there were no reportable injuries in Grady County last week. He told the Commissioners that he would be conducting the monthly Corporation Commission Fuel Leak Tank Inspections for all 3 barns, monthly Fire Extinguisher Inspection for all our County facilities, and following up with Benneh FEMA PDM. Bobby concluded with the Radon level in the basement of the DA's building being at a 14.75 which is above the safe range of below 4.00. Commissioner Walker told the Board that he spoke to the District Attorney and he said it would be fine to put a door on the basement and a ventilation pipe if needed. Ralph Beard reported to the Board that he has been checking prices on a new truck for Bobby Cantu.
