Minutes of the County Commissioners Regular meeting held on November 22, 2021

The Board of the Grady County Commissioners met on this day for an regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, and Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, and Ralph Beard

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the November 15, 2021 regular meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

GCEMA/Fire Report/Safety Director: Dale Thompson was absent. Kim Duke reported to the Board that the Fire Board meeting was last Tuesday and she brought the Board minutes and financials to the meeting for them to review. Kim had Purchase Orders Requisitions. Kim also stated that the Bailey Fire Station was wanting to purchase a fire engine from Chickasha Fire Department that was wrecked, they felt that they could get it repaired for less than a new one. However, they would want to inspect it further. Bobby Cantu informed the Commissioners that he has the Corporation Commission Fuel Leak Tank Inspections and the County Fire Extinguisher Inspections completed. He explained to them that he sent a letter to the Judges asking for a recommended time to finish getting the beds out of the Jail due to the noise involved with this process.

Mr. Spellman gave a COVID-19 report. He said the numbers were down but the hospitalizations were up. He stated that the hospital is having a Pediatric Vaccine clinic on Tuesday, November 22, 2021 and he wanted the Commissioners to know that the FDA has approved that all adults need to get a booster.

Commissioner Beard stated that he had set up a Special Board of Commissioners meeting for November the 29, 2021 at 1:00 to address all applications for the American Rescue Plan Act money. Mr. David Floyd and Ms. Lynn Driver will have a presentation and there will also be a question-and-answer period.

No draw request from the Grady Memorial Hospital.

Kirk Painter made a motion to approve a release of the Lien Agreement between Grady County and Lori Lee, S 50 Lot 2 of Block 207 in Chickasha-OT. It was seconded by Mike Walker. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve the signing of the Purchase and Sale Agreement between St. Clair Properties, LLC and SMN Investments, LLC and Grady County for the purchase of Property located at 205 W. Chickasha Ave., Chickasha, 73018 in the amount of \$700,000.00. It was seconded by Ralph Beard. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Ralph Beard stated that he would like for the Board to go over to the new building and make decisions on how they want the Commissioners meeting room setup. He also said he would be getting in contact with the tenants in the building to see if they would like to rent the places they are occupying as of now and signing a contract on this agreement.

Ralph Beard made a motion to remove Larry Hayes from the Grady County Fire Board as the Cox City Representative. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Commissioner Beard spoke with Larry Hayes about the materials for the Cox City building being located on Mr. Hayes property and how he would come and get them and move them to the County barn until the building was ready to be built.

Kim Duke spoke to the Board that after the bidders looked at the materials that the Fire Station had located at Larry Hayes property, they discovered that there were materials missing. They also needed to get insurance quotes and equipment quotes, so their price would have to go up to \$36,000.00. So, they would like a chance to re-bid at a later date.

Mike Walker made a motion to re-bid the construction of the Cox City Addition to the Cox City Fire Station. It was seconded by Ralph Beard. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to lapse out the unencumbered balances as of November 22, 2021 from the FY 2020-2021 General Fund and Health Fund. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to lapse out the unencumbered Cash Fund balances as of November 22, 2021 from the FY 2020-2021 and move to the new FY 2021-2022. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to reserve the amounts to pay unliquidated encumbrances and outstanding claims for FY 2020-2021. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to deposit check number G035327 from Association of County Commissioners of Oklahoma Self Insured Group to the General Fund (0001) for the reimbursement for Boomer Environmental charges for water extraction in the total amount of \$11,222.09.
