Minutes of the County Commissioners Regular meeting held on September 7, 2021

The Board of the Grady County Commissioners met on this day for an regularly scheduled meeting with the following board members: Mike Walker, Kirk Painter, and Ralph Beard.

The meeting was called to order and roll call: Mike Walker, Kirk Painter, and Ralph Beard

The meeting was opened with the "Pledge of Allegiance"

Mike Walker made a motion to approve the minutes of the August 30, 2021 regular meeting. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

GCEMA/Fire Report/Safety Director: Dale Thompson informed the Commissioners that he had completed the bid specs for the Hazard Mitigation Plan and he is in the process of finishing the Emergency Management fence quotes. Kim Duke needed some Requisition requests and told the Board that she would be getting with Sydney soon on bid specs for the Cox City building. Bobby Cantu reported to the Commissioners that there were no reportable injuries in Grady County last week. He gave an update concerning the X-ray machine in the Security Vestibule. He informed the Board that H &H Plumbing has the lift station and grinder installed for the Courthouse and are starting on the grinder for the Grady County Jail this week. Bobby reported that the they are still evaluating what the issue could be with the basement Courtroom still having a slow water leak. Bobby asked the Commissioners if they were still able to help this week with the cleanup and removing of the beds in the jail. Ralph Beard and Kirk Painter responded yes that they had it on the schedule. He told the Board that he was out on two vehicle accidents last week.

Dale Thompson reported to the Board that there are 254 new COVID cases and 134 deaths altogether in Grady County. Dale informed the Board that Grady County has the lowest vaccination rate in Oklahoma.

Ralph Beard gave the update on the American Rescue Plan Act Money, he told the Board that our lawyer David Floyd is still working on the application and getting it ready for the website. He said that David Floyd spoke with the Grady Memorial Hospital CEO, Mr. Spellman last week and is now working with him to see how the money could help the hospital.

Presentation from Grady Memorial Hospital requesting an allocation from the County's American Rescue Plan Act Funds for Capital Improvement, Revenue Replacement, and Staffing Needs. Ms. McAdoo, Grady Memorial Chief Financial Advisor was present and spoke to the Board; they spoke to David Floyd and submitted to him the calculation of loss revenue of \$1,414,377.59 during Covid when they compared the numbers from 2019 to 2020. They also have a \$300,001.04 loss in Use Tax which is what they receive from the County. Ms. Cathy Groseclose, Hospital Patient Care Services is also requesting funds to hire traveling nurses which would be \$156,000.00. The 3rd request was a sign-on bonus and retention pay for which is up to \$1.4 million, she explained that the hours worked is how they calculated this number, she said they are trying to stay comparable with other hospitals. They said they would like to be on the agenda next week to get started on this process as soon as possible.

No draw request from the Grady Memorial Hospital.

Mike Walker made a motion to approve the bid request for the updating of the Grady County Hazard Mitigation Plan. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to award the quoted bids for the fencing project around the Emergency Management Warehouse. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Ralph Beard made a motion to approve reviewing of insurance claims and award the quoted bid to repair the roof for Acme Station - Grady County Fire Department to Tayco in the amount of \$31,480.00. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Kirk Painter made a motion to accept a bid on the following property:

Mike Walker made a motion to approve lapse out the unencumbered balances as of September 6, 2021 from the FY 2020-2021 for General Fund and Health Fund. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve lapse out the unencumbered Cash Fund balances as of September 6, 2021 from the FY 2020-2021 and move to the new 2021-2022. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve to reserve the amounts to pay unliquidated encumbrances and outstanding claims for FY 2020-2021. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Kirk Painter made a motion to sign the 2021-2022 Grady County Estimate of Needs and acknowledgement of the letter from the Excise Board. It was seconded by Ralph Beard. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Ralph Beard made a motion to table an interlocal agreement with the City of Chickasha to redo Pikes Peak Road. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Mike Walker made a motion to approve the installation of road signs that prohibit commercial trucks. The proposed signs will read "No Commercial Trucks." The location of the proposed signs and the roads affected by the 6 new signs are located within District 1, and are more specifically described as follows: Highway 37 southbound to Sooner Road. It was seconded by Kirk Painter. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

Ralph Beard made a motion to approve the action to sign change order #2 Bridge and approaches county road (NS-2958): over rush creek, 5.4 miles North of the SH-29 Junction near Cox City, project length = 0.164 Mile. It was seconded by Mike Walker. AYE: Mike Walker, Kirk Painter, and Ralph Beard.

New Business: Ralph stated that he received a letter from Oklahoma LED regarding replacing all lightbulbs with LED lightbulbs, he said it could end up saving money for the County. He wanted to know if the other Commissioners had any problem with doing this. Ralph received an email on information about redistricting and wanted to let the other Commissioners know that there would be more information to follow. The Commissioners then had discussion on the timeline on which this process has to take place. They said that the entire process should be finalized by November 30, 2021. The Commissioners discussed on going forward on the Courtrooms remodeling and renovations. Mike Walker said he would like to see only one courtroom down at a time.
