## Minutes of the County Commissioners Regular meeting held on March 21, 2022

The Board of the Grady County Commissioners met on this day for an regularly scheduled meeting with the following board members: Ralph Beard, Kirk Painter, and Mike Walker.

The meeting was called to order and roll call: Ralph Beard, Kirk Painter, and Mike Walker

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the March 14, 2022 regular meeting. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

GCEMA/Fire Report/Safety Director: Dale Thompson told the Board there was a chance of rain this week. Dale stated that he received an email that the President has put into place a Consolidated Appropriation Act of 2022, and it will affect the FEMA reimbursement from January 1, 2020 to December 31, 2021. The Act will change the reimbursement amount from 75% to 90%. Dale told them that he would be receiving more information on this as it comes out. He said that the State ISO reported that there were 120 acres, one house and some out buildings burned in Tuttle on Sunday. Alex also had a fire; it was put out quickly and a fire at Bradley started at around 6:30. Kim Duke handed out minutes and financials to the Commissioners from the last Fire Board meeting and had requisition requests. Kim stated that she wanted to commend all the volunteer firefighters on their efforts in the fire yesterday. Bobby Cantu reported that there was one injury two weeks ago. Bobby stated that he has completed the Spill Control and Countermeasures Plan (SPCC) annual training with District #1. He gave an update on the jail and they are going to get started this week on painting. He stated that he would be attending the "Is Your Workplace Safe & Sound" safety training meeting this Tuesday in Oklahoma City. He stated he would be conducting a District #2 Monthly Safety meeting and the Sheriff's department first quarterly safety meeting. Bobby informed the Board that he had completed his Emergency Vehicle Drive Training Course (EVDT) and told them that there were 24 from the Fire Department there. Bobby said that to have that many give up a Saturday to come to a training says a lot about the volunteers.

Ralph Beard made a motion to approve the continuation of the burn ban for Grady County from February 22, 2022 for 7 days with a provision to allow Farmers and Ranchers to have a controlled burn if guidelines are followed as prescribed by the Forestry Department. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Commissioner Beard stated that David Floyd with Floyd & Driver has received the hospital applications as well as other applications and they are reviewing those for the County at this time. Pat Brooks was present and informed the Board that he was advised by the Federal Home Loan Bank Grant at the end of the year that they missed getting approved by 5 points. However, they will be reapplying for this and other additional grants. They are also having an engineer looking at how to build the shelter more economically.

Ralph Beard made a motion to approve the surcharge \$133,081.46 from OPEH&W to be reimbursed with ARPA money. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Kirk Painter made a motion to approve the estimate of needs, request for appropriations, transfer of appropriations for Sales Tax FD, Sales Tax SC, and Treasurer. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Audience Participation: Craig Parham was present and dropped off plans for the drainage system in Amber. He also had a question on Amber Road between 81 and 92 that is a bus route and getting pretty bad. Kirk Painter stated that he has been working on getting that stretch of road approved with CED. It is currently in third place on the CED District list and is scheduled to begin in 2023 and will be done in phases.

Karie Morgan was in attendance and had questions about a road closure and a two-mile section that was skipped South of the Farewell Station. She wanted to know how the Commissioner's decided which road they would fix. She reported to the Commissioner that County Road 1430 had a bad pothole. Commissioner Beard stated that he has numerous pot holes that they are fixing and haven't made it that far yet. When they get a call about a pothole, they try their very best to get there as soon as possible. However, if they are currently on a project, they would finish that first.

Maretta Rogers was present and she stated that she is seeing the same issues today as she, seen in 2008 with the Grady County Fire Board. She stated that the whole Fire Board needed to be dismissed. The Commissioner's need to talk with the volunteer's more to see what is going on with the Fire Department. Kirk Painter stated that he talks to all three of his station's volunteers and Fire Chief's. Mr. Painter stated that he is not very proud of the leadership happening with the Fire Board since I've been in office. They appoint the Fire Board and that they haven't had a full Board for a long time until now. If the Board member does not attend meetings they are removed. Ms. Rogers

wanted to know when the meetings were and how the public was supposed to know when the meetings were. Kirk Painter stated that they are posted every month. Mr. Beard stated that it is posted every month and they are open meetings and everyone is welcome to go. He stated that if anyone in the public wanted to go, they can get ahold of a Board member or the Secretary to find out. Ms. Rogers wanted to comment on Ralph Beard's employees. She stated that she stopped and complimented one employee because he was mowing, when she has seen other employee's sitting in their truck. Ms. Rogers stated that the Chairman of the Fire Board needed to be removed. Mr. Beard stated that he understands the controversy however, this Fire Board is full for the first time and the Commissioner's stand behind the Fire Board.

Ralph Beard made a motion to adjourn. It was seconded by Mike Walker. AYE: Ralph Beard, Kirk Painter, and Mike Walker.
