Minutes of the County Commissioners Regular meeting held on July 25, 2022

The Board of the Grady County Commissioners met on this day for an regularly scheduled meeting with the following board members: Ralph Beard, Kirk Painter, and Mike Walker.

The meeting was called to order and roll call: Ralph Beard, Kirk Painter, and Mike Walker

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the July 18, 2022 regular meeting. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Kirk Painter made a motion to approve the minutes of the July 19, 2022 emergency meeting. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter. Mike Walker abstained

GCEMA/Fire Report/Safety Director: Emergency Management Director Dale Thompson reported that one of Ralph Beard's projects was up for review and may be eligible to up to 90% reimbursement. He gave the Board a copy of the drought map from last week and reported currently we are at a moderate level. He stated that he would be attending a Crisis Management Class for school-based incidents on August 10th and that the registration was filling up quickly if any of the Commissioner's wanted to attend, they needed to sign up as soon as possible. He also reported that he has had two meetings with the Health Department over active shooters. He will be attending the OMA training on Friday. He reported the weather outlook for this week showed lower temperatures and a 40% chance of rain. Kim Duke was in attendance and stated she only had a few PO requests for the Commissioners. Bobby Cantu reported that the Drug and Alcohol testing price would be increasing. Ralph Beard stated that he has been in touch with Kean Spellman and Grady Memorial also does this service, we may in the future decide to use the hospital instead. Bobby Cantu stated that he would be speaking to Anadarko kids for Career Day through Southwest Youth and Family Services. He also stated that he would be attending the annual summer safety conference.
