## Minutes of the County Commissioners Regular meeting held on November 7, 2022

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Ralph Beard, Kirk Painter, and Mike Walker.

The meeting was called to order and roll call: Ralph Beard, Kirk Painter, and Mike Walker

The meeting was opened with the "Pledge of Allegiance"

Ralph Beard made a motion to approve the minutes of the October 31, 2022 regular meeting. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Kirk Painter made a motion to approve the plat map called Destiny Hills presented by Darryl Mason. The roads will not be maintained by the County. It was seconded by Mike Walker. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Kirk Painter made a motion to approve the re-plat of Winter Creek Golf & Country Club, Part J presented by James French, and the roads will not be maintained by the County. It was seconded by Mike Walker. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

GCEMA/Fire Report/Safety Director: Emergency Management Director, Dale Thompson reported that Emergency Management would be attending the IST and Communication training. Wednesday the class will be at the Caddo Nation Complex in Binger, and Thursday the class will be at the CVTC in Chickasha. Dale gave the Commissioners the information on the annual courthouse closing protocol and gave them an update on the cooler weather at the end of the week. Kim Duke was absent. Bobby Cantu reported that there were two reportable MVA's and one injury last week in the County. He informed the Board that the FMSCA (Federal Motor Carrier Safety Administration) would need to be looked at next year by January 6, 2023. Bobby stated that he conducted a new employee safety orientation Monday morning and would conducting the last quarterly safety meetings for the year for the following departments: Emergency Management, District #3, Assessor's Office, Court Clerk's Office, County Clerk's Office, and the Treasurer's Office. Bobby informed the Board that the structure engineer Billy Wiginton from Wallace Design Collective did a walk through on the part of the building that was added for the elevator and stairs. The report showed that it did not pose a life safety threat. However, if changes were to occur, they would need to be contacted for another inspection. Bobby said that he would get in contact with CMS to get started on making the repairs. The Engineer did want noted that he found some other issues at the landing that would need some attention and told Bobby they would draw up a proposal on these items that they found in the inspection process.

No draw request from the Grady Memorial Hospital.

ARPA Discussion: Dale Thompson gave the Board a letter clarifying that the purchase order made for \$352,000.00 for the new Communications/Command Vehicle was supposed to be two purchase orders. The PO that was issued to NOMAD was supposed to be \$340,700.00 for the purchase of the Mobil Command Vehicle and an additional PO is needed for Stolz for \$10,772.48 for the upfitting of the vehicle. The original approval was not itemized, therefore purchasing would not know to split those purchase orders into two different vendors. The problem has been taken care of, but Dale wanted the Board to be aware of amounts and two different vendors.

Dale Thompson recommended No Burn Ban. No action on Burn Ban.

No Action on applying for the Local Assistance and Tribal Consistency Fund form the U. S. Department of the Treasury. Commissioner Beard stated that this should be looked at in January with the new Commissioners coming in.
