Minutes of the County Commissioners Regular meeting held on October 31, 2022

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Ralph Beard, Kirk Painter, and Mike Walker.

The meeting was called to order and roll call: Ralph Beard, Kirk Painter, and Mike Walker

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the action upon resolution authorizing and approving the incurring of indebtedness by the Trustees of the Grady County School Finance Authority to be accomplished by the issuance of lease revenue bonds, bonds, notes or other evidences of indebtedness in one or more series on a tax-exempt or taxable basis, at a premium or discount, in the aggregate principal par amount of not to exceed Eight Million, Six Hundred Thousand Dollars (\$8,600,000) to provide funds to complete the acquisition, construction, equipping, renovating, and remodeling of school buildings, acquiring school furniture, fixtures and equipment and acquiring and improving school sites related to Elementary School District No. 96 Grady County, Oklahoma ("Middleberg Public Schools" or the "District"); establish a reserve fund, if any, capitalize interest and pay costs of issuance and all matters related thereto, including but not limited to the waiver of competitive bidding thereof; and declaring an emergency. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Mike Walker made a motion to approve the action upon resolution authorizing and approving the incurring of indebtedness by the Trustees of the Grady County School Finance Authority to be accomplished by the issuance of lease revenue bonds, bonds, notes or other evidences of indebtedness in one or more series on a tax-exempt or taxable basis, at a premium or discount, in the aggregate principal par amount of not to exceed Nine Million, Two Hundred Thousand Dollars (\$9,200,000) to provide funds to complete the acquisition, construction, equipping, renovating, and remodeling of school buildings, acquiring school furniture, fixtures and equipment and acquiring and improving school sites related to Independent School District No. 95 Grady County, Oklahoma ("Bridge Creek Public Schools" or the "District"); establish a reserve fund, if any, capitalize interest and pay costs of issuance and all matters related thereto, including but not limited to the waiver of competitive bidding thereof; and declaring an emergency. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Ralph Beard made a motion to approve the minutes of the October 24, 2022 regular meeting. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Mr. Pat Brooks and Mr. Zack Bowles was present. They came to speak with the Commissioners about the request they made in July of 2021 for the Resurrection House project. They applied for a \$750,000.00 Federal Home Loan Grant, the \$1,250,000.00 ARPA money, along with private donations of \$300,00.00, and a bank loan of \$100,000.00. The Federal Home Loan grant was denied and the ARPA money was contingent on the approval of the FHL grant. Mr. Brooks said they came back in January and told the Board that they were going to downsize the project to try and reduce the costs and work on a replacement grant for the \$750,000.00. He stated that the project plans have been revised and have been sent to CMS Willowbrook and will need some revised figures to bring back to the Board. He explained to the Board that they have apartments that they are in the process of selling right now for \$600,000.00 to make up some of the costs that were not awarded from the FHL grant. Mr. David Floyd

stated that the award of the \$1,200,000.00 was contingent on the FHL grant, so those funds were reallocated and now there is only \$900,000.00 left unallocated in the ARPA Grant Fund. However, he did say they would not have to apply for the ARPA money again, they would just have to bring their costs and verbiage up to date. Mr. Brooks mentioned that was there a chance that the GCHFA was disbanding and could they possibly get the County to relinquish those funds to the project or see if the GCCJA had any financing for this project. Commissioner Beard responded, that would be up to the District Attorney of what we could do with those funds. If that were to happen, he reiterated, that he would like to see the County help out on this project. Commissioner Painter stated that at a Grady Memorial Hospital Board meeting the question came up if this was servicing the single homeless or if it was for families. Mr. Brooks answered in saying that it would service both but it would give them more separation between the male and female population. He stated that there are rules and qualifications that all applicants have to have. The Resurrection House is temporary housing and LSI is transitional housing into permanent housing, and they are both going to be in the same location. Zack Bowles is heading up the alliance between other organizations and the additional 7,130 square foot of room will bring more space needed for families. It would also create an environment that is only for the homeless of Grady County and create an alliance of the organizations in the County that help serve the needy.

GCEMA/Fire Report/Safety Director: Emergency Management Director, Dale Thompson reported that he and Amanda finished the FEMA class. He stated that Tuesday and Wednesday, Lawton Communications is coming to check the repeaters for Emergency Management and 911 dispatch. Dale wanted the Commissioners to know that he received his EMPG \$30,000.00 grant for the next year and he said there were good chances of rain for the next weekend. Kim Duke asked the Commissioners to sign a Requisition for the Fire Department. Bobby Cantu reported one reportable injury last week. Bobby said he had completed the monthly fuel tank, Fire Extinguisher, and facility walk-through inspections. Bobby told the Commissioners about an Engineering company in Oklahoma City named KFC that would look at the Courthouse structure for the add-on addition to the building to see if it is structurally sound. He would give us his professional opinion. The Commissioners felt that we should get other quotes from other vendors before we proceed.

No draw request from the Grady Memorial Hospital.

Dale Thompson recommended No Burn Ban due to the potential rainfall this coming weekend. No action on the Burn Ban for Grady County.

Ralph Beard made a motion to approve of accepting a donation of a Transport Van #6 from the Grady County Criminal Justice Authority to the Sheriff's Office. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Mike Walker made a motion to approve the reappointment of Marcus Ball to the McClain-Grady County EMS District 1 Board of Trustees, term expiring October 31, 2027. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Kirk Painter made a motion to approve the sick leave donation. It was seconded by Ralph Beard. AYE: Ralph Beard, Kirk Painter, and Mike Walker.

Ralph Beard made a motion to approve the utility/pipeline road crossing permits, waterline/fast-line permits, and driveway/tinhorn permits for District 1, 2, and 3. It was seconded by Kirk Painter. AYE: Ralph Beard, Kirk Painter, and Mike Walker.
