He stated that the coldest days would be Thursday and Friday with precipitation chances on Thursday. Kim Duke reported that the Purchase Order had been opened for the repair for the heater at the Farewell station and the Fire Board meeting is Tuesday night December 20, 2022. Bobby Cantu informed the Board that he would be conducting the monthly Corporation Commission fuel leak tank and fire extinguisher inspections with all 3 district barns and all county owned facilities. Bobby stated that he was working on the 2023 Disaster Recovery and Hazard Communication Plan and the Drug and Alcohol testing policy. Bobby would like to set a training for each department head in the County with Motion Works to better understand the role and responsibilities of the DER.
