The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

GCEMA/Fire Report/Safety Director: Dale Thompson informed the Commissioners that the Paradigm Pipeline class is Wednesday, February 8th at 11:30 and the Emergency Management conference is February 26th through March 2nd. Dale reported that there were chances of rain this next week. Kim Duke reported to the Board that the Fire Departments are in training and that there is a fundraiser at the Ninnekah Station for a volunteer firefighter on February 19th from 11:00 - 2:00. Kim stated that she gave a copy of the roster to Commissioner Bray. Bobby Cantu gave an update on the 3rd floor and stated that he completed the Quarterly Safety meeting with District #3 and will be conducting District #1 and the County Clerk's this week. Bobby reported that he would be going to the Pipeline Safety meeting on Wednesday. Bobby informed the Board about the County ID badges and stated that the Emergency Intercom System is in place. Bobby updated the Commissioners on the Air Purifier Filter for the Standalone Units and how they are going to be taking care them in the future.

ARPA discussion: No Action
