Minutes of the County Commissioners Regular meeting held on March 13, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the March 6, 2023 regular meeting. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

GCEMA/Fire Report/Safety Director: Dale Thompson reported to the Commissioners that they have a Southwest Emergency Management meeting Thursday from 10:00-3:00 in Lawton. He stated that he is still updating the Hazard Mitigation plan. Dale spoke to the Board on updating the value of County buildings to ACCO. Kim Duke informed the Board that the Friend Fire Department appreciation dinner went well and she is working on getting the fire departments their own tax identification number. Bobby Cantu reported that he would be conducting safety talks with the Election Board, Treasurer's office, and Maintenance. He stated that the OSU Extension/USDA building parking lot has been finished as well as the Courthouse's structural issues.

No draw request for Grady Memorial Hospital.

ARPA discussion: Commissioner Painter stated that the Chairman of the Fire Board is resubmitting the Fire Rescue Truck application to Floyd and Driver.

Zachary Davis made a motion to appoint Bruce Anthony to the Grady EMS District Board of Trustees, to finish the unexpired term of Scotty Turner ending June 30, 2027. It was seconded by Kirk Painter. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve of a quote from TCS Floors to strip and wax the floors in the Courthouse in the amount of \$2,653.56. It was seconded by Zachary Davis. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Zachary Davis made a motion to approve the action to update the date of the County Auction to June 15, 2023 due to a conflict with the Auctioneer. It was seconded by Kirk Painter. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Dale Thompson stated that the need for his office for the Courthouse to have a generator is due to their phone system running on the Courthouse server, in case of an emergency they need to be able to have their phone lines work, even if the employees are not at work. Commissioner Painter stated that his concern was the court cases that have been back logged, and if the electric goes out for two hours, it would cause them to get further delayed. The Commissioners decided to move forward with bidding a generator for the Courthouse and opening a Purchase Order for the Electrical Engineer. The Board said there would need to be bid specs written.

Zachary Davis made a motion to approve of remodeling/repairing the bathrooms and plumbing at the Grady County Courthouse. Commissioner Davis would like to ask CMS Willowbrook to come and survey the Courthouse plumbing issues. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.
