Minutes of the County Commissioners Regular meeting held on April 10, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the April 3, 2023 regular meeting. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Terry Hawkins and Jim Gerlach were present to speak to the Board regarding the Women's facility new addition.

Kirk Painter made a motion to approve the action to consider adoption of a Resolution approving the incurrence of indebtedness by the Grady County Criminal Justice Authority issuing its Revenue Note, Series 2023 in an aggregate amount not to exceed \$3,000,000; approving a Supplemental Facilities Lease between the Board of County Commissioners of Grady County, Oklahoma and the Authority; providing that the Trust Indenture, as amended, creating the Authority is subject to the provisions of the Note Indenture; authorizing the issuance of said Note; waiving competitive bidding and approving the proceedings of the Authority pertaining to the sale of said Note; and containing other provisions relating thereto. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve the tabled item of a plat map called Falcon Ridge. The County will not be maintaining the road. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

GCEMA/Fire Report/Safety Director: Dale Thompson gave the Board a graph on the drought monitor. He explained that we are in 3 different categories at this time and that we have a few chances of rain Monday and another one on Friday. Dale stated that the Weather Preparedness event at Walmart was successful and they were assisted by a Boy Scout earning a badge. He informed the Board that he would be going to DPS to drop off radios this afternoon in order to have them programmed. Kim Duke reported that she has received the tax identification number that she applied for the Grady County Fire Department. She stated that the Bridge Creek fire department gave a pumper truck to the Harold Fire Station and the Harold Fire Station is transferring theirs to the Bradley Fire Station. Kim handed out minutes and financials to the Commissioners from the last meeting. Bobby Cantu reported that he had a meeting with the new District #3 Safety Coordinator. He was at the ACCO meeting last week and there were some reported accidents in the hallway of the Courthouse. He is currently looking at some solutions with the tripping hazards.

Mr. Spellman was in attendance to speak to the Board; he thanked them for their willingness in helping the hospital get extra security. In the last meeting Mary Beth Malone, CNO and Stephanie Tsonetokoy, RN-House Supervisor from Grady Memorial were in attendance to discuss violence in the hospital from patients.

Commissioner Painter read information that Lynne Driver sent over about the ARPA funds. The memo stated that the following awards had been completed for the following fire departments: Pioneer, Farwell, Friend, Harold, and Rush Springs and expect the Naples revised application any time. The last awards for these fire departments should leave the ARPA money with \$74.94. The County will have \$123,000.00 in interest earned from the ARPA funds that will go into the General Fund and will not be awarded through the ARPA process.

Sheriff Boggess also stated it is easier for all his deputies to carry the same type of gun so he can purchase ammunition for one type in bulk saving money.

Acknowledgement of the purchase of forty (40) GLOCK pistols for \$39,939.20 from GLOC, Inc. by the Grady County Sheriff.

Kirk Painter made a motion to approve awarding Local Assistance and Tribal Consistency Funds ("LATCF") to the Grady County Sheriff's Office for purchase and installation of a Mindshare VOIP Dispatch System, in an amount not to exceed Eighty Thousand Dollars (\$80,000.00). It was seconded by Zachary Davis. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Zachary Davis made a motion to approve a quote from Digi Security Systems for an upgrade to security systems on State Contract # SW1048D in the amount of \$73,908.88. It was seconded by Kirk Painter. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Mr. Wayne Wright with Larson Design Group and Mr. Rocky Hollingsworth with Clifford Power were in attendance to discuss the generator for the Courthouse. Commissioner Davis stated he felt there were other things that needed to be addressed before we get a generator. He said he would like to see the County look at updating the electrical and natural gas lines.

No action on the tabled item for an engineering services agreement between Larson Design Group and Grady County.

Gary Bray made a motion to approve the bid request for the re-bid of one (1) or more, new or used Semi Truck for District 3. It was seconded by Kirk Painter. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

No action on the bid request for the plumbing repairs for the Grady County Sheriff's Office.

Zachary Davis made a motion to reject all bids for a 66" Pad Foot Roller for Grady County
District 1. Commissioner Davis said he checked with Sourcewell and could purchase a Foot Roller at a

lower cost than the bids received. It was seconded by Kirk Painter. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Zachary Davis made a motion to approve the bid for one (1) or more class 8, 6-wheel semitruck for Grady County District 1 from D & D Truck Sales Inc. New Business: Sheriff Boggess spoke to the Board about some items that would be in his budget this year. The first one was that he wanted to have the County pay for half of the employee's family's insurance. The Sheriff also said he would like to see the County adopt monthly vacation accrual and he would be adding a higher safety bonus on his budget. Right now, the highest paid safety bonus for County Highway is \$250.00 and the highest paid safety bonus for the Sheriff's department is \$100.00. He was concerned that a deputy putting their life on the line would receive less than a roadworker. The Sheriff's last request was a new SWAT team vehicle. The one they currently have had multiple issues and the Sheriff's Office must have an armed vehicle for some of the raids they have been doing lately.

Bobby Cantu wanted to know if the Board would allow Lisa Hannah to get a waiver signed by anyone wanting to go upstairs to pull records instead of having her employees stopping what they are doing and taking their time to pull records. Charles Sifers A.D.A. stated this was not possible at this time.

The Commissioners set an Officials meeting for April 17, 2023 at the end of the Commissioners meeting.

Kirk Painter made a motion to adjourn. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.
