JOB DESCRIPTION

RESERVE DEPUTY

Definition:

Under general supervision, enforces the laws of the State of Oklahoma and answers calls for service.

Essential Job Functions/Minimum qualifications:

Reserve Deputies must complete the GCSO Field Training Program to perform their duties. The training program is designed to ensure proper monitoring and provide effective instruction throughout the new recruit's training in accordance with State and Federal laws.

Each commissioned Reserve member of the GCSO is also required to complete annual continuing education hours as mandated by CLEET as well as the GCSO. In addition, Deputies are trained in many other areas pertaining to their work environment and job-related duties.

Job Functions

- Other essential duties and functions include, but are not limited to the following;
- Enforce all Federal, State, County and Municipal Codes (within contract cities), Statutes or Ordinances.
- Arrest and Detention of criminal offenders.
- Respond to crimes in progress both emergency and non-emergency in nature.
- Protect life and property against criminal acts and to preserve the peace.
- Provide protection against any harmful acts, both willful & inadvertent, whether of a criminal or non-criminal nature.
- Provide emergency first responder level assistance to persons in various states of distress.
- Provide initial services to persons suffering from mental illness and that may be in a state of crisis.
- Assist other law enforcement agencies and personnel as needed.
- Patrol the unincorporated areas of the County in an effort to prevent criminal acts by offenders.
- Investigate all criminal acts, process the recovery of stolen property and vehicles, write reports on all incidents, and make follow-up reports as required.
- Prepare case records for presentation to appropriate court for filing of charges and testify as required.
- Handle all emergencies, disorders, & special events & keep supervisors informed of all matters of importance.
- Provide various other types of public service and law enforcement duties to all persons within the county.
- Participate in Community Service Programs throughout Grady County

Physical Demands

- While performing the duties of this job, the employee is regularly required to stand; walk; use hands to fingers, handle or feel; reach with hands and arms; talk or hear; and taste and smell.
- The employee is occasionally required to sit; climb or balance; and stoop, kneel, crouch, or crawl.
- The employee regularly lifts and/or moves up to 25 pounds, frequently lifts and/or moves up to 50 pounds, and occasionally lifts and/or moves more than 100 pounds.
- Specific vision abilities required by this job include close vision, distance vision, peripheral vision, depth perception, and ability to adjust focus.

GRADY COUNTY SHERIFF'S OFFICE REQUIREMENTS FOR RESERVE DEPUTY

MEETINGS

Reserve meetings will be held on the first Tuesday of the month. You will be required to be at each meeting. If you will not be able to attend, you must advise on of the Reserve Lieutenants at least 12 hours prior to the meeting time. If any reserve has 2 unexcused meetings, they may be removed from duty.

TRAINING

Reserves will be required to accumulate at least 24 hours of continuing education every year.

EQUIPMENT

You will be required to supply your own weapon, and uniforms. Duty belt is Sam Browne style leather, high gloss duty belt and gear.

REQUIRED EVENTS

You will be asked to work a shift at various events in the county. Those events may be Tuttle's Ice Cream Festival, Rush Springs Watermelon Festival, Grady County Fair, and other county events as needed.
