Minutes of the County Commissioners Regular meeting held on May 8, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Gary Bray, Zachary Davis, and John Nicholas.

The meeting was called to order and roll call: Gary Bray, Zachary Davis, and John Nicholas.

The meeting was opened with the "Pledge of Allegiance"

Zachary Davis made a motion to approve the minutes of the May 1, 2023 regular meeting. It was seconded by Gary Bray. AYE: Gary Bray and Zachary Davis. Abstain: John Nicholas.

Mary Parrish with the OHCE was in attendance and gave the Commissioners a report on the community events they are involved in, and told them their membership has increased by 13.25%. She stated that there are 5 groups in the OHCE and a brand-new group in Tuttle at this time.

John Nicholas made a motion to approve the proclamation for OHCE (Oklahoma Home and Community Education) week. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and John Nicholas.

Zachary Davis made a motion to approve a plat called Hill's Whispering Trails Phase Three. The roads will not be maintained by the County. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and John Nicholas.

GCEMA/Fire Report/Safety Director: Dale Thompson stated that he has been working on his inventory. He reported that they have done 283 new passports from the first of the year. Kim Duke has been working on the list to surplus from the Fire Department for the auction. Kim stated that they have been working on getting CPR classes and extracting classes. She stated that they had been doing vehicle accidents and worked a structure fire in Ninnekah. Bobby Cantu informed the Board that he was working on doing quarterly meetings. He stated that the Pro-grip has been put on the curbs at the jail and the courthouse for a slipping hazard, he is also repairing a fire extinguisher and reported on a vehicle accident. Commissioner Davis suggested doing a monthly report versus a weekly report. He stated that they would leave the item on the agenda in case there was something that they needed to address.

Zachary Davis made a motion to start having a monthly report from Emergency Management, Fire Department, and Safety Director at the end of the month unless they have something to address earlier in the month. It was seconded by Gary Bray. AYE: Gary Bray, Zachary Davis, and John Nicholas.

Gary Bray made a motion to approve transfer Emergency Managements 1993 Blue Bird Bus and equipment to the Caddo Nation. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and John Nicholas.

Charles Sifers A.D.A. stated that the District Attorney's office does not support the resolution and recommend it not be approved. Commissioner Davis stated that he was concerned in how the resolution was worded. He said he felt like this money being it was set up by the courts we should be careful in how we release the money.

Gary Bray made a motion to not approve the resolution requesting Grady County distribute all State-awarded Opioid Settlement Funds for the purpose of purchasing medication-assisted treatments, Opioid reversal medications and providing harm prevention/reduction strategies and resources to Grady Memorial Hospital. Gary Bray made a motion to reject the bids for one (1) new 5th wheel trailer for District 3. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and John Nicholas.

Zachary Davis made a motion to reject the bid for one (1) EMR vehicle for Pioneer Fire Station, and re-bid due to no bids received. It was seconded by John Nicholas. AYE: Gary Bray, Zachary Davis, and John Nicholas.

Gary Bray made a motion to approve removing Doug Chaney and adding Sherri Rios as receiving officer for the following requisitioning departments: 0830-District #3, Highway District 3, FEMA Highway Projects Dist. 3, Restricted Highway District 3, and CIRB-MV District 3. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and John Nicholas.

John Nicholas made a motion to appoint Commissioner Bray to discuss the suggested donation amounts for meals with the Senior Citizen Board. It was seconded by Zachary Davis. AYE: Gary Bray, Zachary Davis, and John Nicholas.

The Board discussed the Senior Citizen issue further and decided to have the Grady County Senior Nutrition Board call a meeting and discuss what amount all Senior Center's should be charging for their meals.
