Minutes of the County Commissioners Regular meeting held on June 5, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the May 30, 2023 regular meeting. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

GCEMA/Fire Report/Safety Director: Dale Thompson informed the Board that he was checking on the Simplex Channels for the 3 district barns and is getting a quote from Industry Systems to get new computers so he can upgrade to the new Windows 11. Kim Duke reported that the Ninnekah dinner went well and she is reminding all the fire stations to get their auction items gathered and to her by next week. Bobby Cantu stated that he was finishing up the Safety meetings and the fire door in Bari Firestone's office was being installed soon.

New Business: Sheriff Boggess spoke to the Board about putting in new counter tops, a sink and refrigerator for the Sheriff's training room. The Commissioners agreed with the Sheriff that this was necessary for training purposes.

Kirk Painter made a motion to approve the following draw request from the Grady Memorial Hospital's sales tax accounts held with First National Bank: Industry Systems - FortiToken 100 (Multi-Factor Authorization) - \$3,178, Industry Systems - Software License -Microsoft SQL Server 2022 -\$3,260.12, Hologic - Breast Biopsy System (Brevsys) - \$84,500, Industry Systems - Computer, Desktop (2) - \$1841.20, Inner Space - Scope Cabinet (Surgery)-\$22,927.19, Medline Industries - Pediatric Crash Cart -\$1,802.96, and Logiquip - Defibrillator Crash Cart - \$1,785.15. Kirk Painter made a motion to approve amending that certain Subrecipient Award Agreement dated as of December 5, 2023, as amended February 6, 2023, from the Board of County Commissioners to Grady Memorial Hospital from American Rescue Plan Act funds to amend the Budget Period End Date by changing June, 2023 to September 30, 2023 and approving the Second Amendment to Subrecipient Award Agreement dated as of June 5, 2023. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kim Duke and Rodney Christian were in attendance to speak to the Commissioners on clarification on the ARPA award they received. They were planning on building a new bathroom with the money, but had since been confused if they were supposed to build the building itself or just the bathroom. Kirk Painter earlier stated that he was going to build the building to house some of his equipment at the fire station. Kim asked if they need to do separate bids and bid both projects at the same time? The Commissioners said they thought this was the best option for this project.

Gary Bray made a motion to approve installing a wall and door into the Passport Office for security. It was seconded by Zachary Davis. AYE: Kirk Painter, Gary Bray, and Zachary Davis. 142 | P a g e

Dale Thompson spoke to the Commissioners about the Jon Boat and let them know that they have an 8 ft. boat at the Pioneer Station that they would use at Lake Burtchi and this one would be housed at the Alex station because they are closest to the river. Chickasha has done away with their dive team and swift water rescue so he would like to see Grady County receive more training for this.

Kirk Painter made a motion to approve the Emergency Management Office purchasing a new Jon Boat and trailer for swift water rescues and dive recovery activities. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to award the quoted bids for the installation of warning lights to the Safety Director's Vehicle to Banner in the amount of \$1,788.34. It was seconded by Zachary Davis. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve a quote from Melton's Heat Air & Electric in the amount of \$2,899.00 for the cleaning and servicing of all A/C units at the Sheriff's Office. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve a resolution approving County Officers Monthly Travel Allowance to the following: Each County Commissioner - \$1,000.00, County Sheriff - \$1,000.00, County Assessor - \$900.00, County Clerk - \$800.00, Court Clerk - \$800.00, Treasurer - \$800.00; contingent upon if each elected official decides to drive their personal vehicle or a county owned vehicle, starting July 1, 2023. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve of allocating all current and future ARPA interest to the Highway Fund. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve the Fund-to-Fund transfer of ARPA interest to the Highway Fund in the amount of \$159,034.23 to be split evenly between each District. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve the FY 2023-2024 Grady County Depository Bank's as follows: Community Bank of Oklahoma – Chickasha, First National Bank and Trust – Chickasha, Liberty

Officials Meeting: Commissioner Bray read the information and communication portion of the Internal Controls from the office from SA&I. Commissioner Painter then proceeded with some items that needed to be addressed in order to move forward with everyone's budget. The Officials discussed raises for the employees and how we want to move forward with them. The Officials talked about doing a matrix and some doing a percentage raise for their employees. The Officials then talked about paying ½ of the employee's family's insurance and when this would become effective. The County Clerk told the Officials that we would have open enrollment in November and it would be effective January 1st, and this change would have to be voted by the Board and go in the handbook. The vacation accruals were discussed next, Sheriff Boggess suggested that we do the accrual because this would help when a new employee came, they would not get in a bind if something came up unexpectedly. The Officials discussed setting a cap on this so that we would not go over the budget that we set each year. The Officials discussed starting this process in January since that is when we calculate employee's vacations normally.

Kirk Painter made a motion to adjourn. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.
