Minutes of the County Commissioners Regular meeting held on July 17, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the July 10, 2023 meeting. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

GCEMA/Fire Report/Safety Director: Dale Thompson reported that last Thursday he met with the Grady Memorial Hospital staff to start the process of doing an Active Shooter Drill. He said the drill has tentative date of November 3rd; they are also hosting the Southwest Emergency Management Quarterly Conference at the Tech Center on Thursday July 20, 2023. Dale informed the Commissioners that he has opened the purchase orders for the FCC licenses for each District barn. Kim Duke told that the regularly scheduled meeting is Tuesday the 18th of July and she is in the process of getting the agenda and financials prepared. Bobby Cantu reported that he finished the district #3 employee's makeup Safety meetings. He stated that he would be doing the Monthly Corporation Commission Fuel Leak Inspections and the Monthly Fire Extinguisher inspections and he would be attending the LEPC meeting this coming Thursday. He informed the Commissioners that Wallace Design was coming on Saturday to get the blueprints drawn for the part of the building that does not have blue prints. Bobby asked the Board if the City of Chickasha could use the Security columns that we have in storage, but we do not know whose inventory they are on. The Commissioners said they would like for Bobby to do some more research on this item.

New Business: Robin Burton spoke to the board about property at 906 NW 12th St. in Chickasha that an individual would like to donate to the County. The Commissioners said they would like to check on this property to see if it would be a property they would want to accept.

Commissioner Painter addressed the Board after receiving a letter of resignation from Ralph Beard as a member of the Grady County Criminal Justice Authority. Commissioner Painter stated that the Commissioners would need to appoint someone to this Board as soon as they could find someone.

Daryn Kirkpatrick (Regional Administrative Director of the Oklahoma State Department of Health District 6), Kayla Jarrett, Mendy Spohn (Deputy Commissioner at the State Department of Health), and John Clark (Deputy General Counsel for the State Department of Health) were present to discuss concerns with the new Grady County Health Department building located at 205 Chickasha Ave, Chickasha, Ok, Commissioner Davis stated that his biggest concern is that there is no agreement between the Grady County Health Department and Grady County; specifically on maintenance on the building and insurance liability. Ms. Spohn informed the Board that ACCO, the Counties insurance, is responsible for the building itself but anything inside the building would be covered under the State insurance for the Health Department. Commissioner Davis stated that he would like to know if the Health Department would like to manage the building, oversee maintenance, and take over the landlord duties of the building; in return the Health Department could receive the rent from these entities. Ms. Spohn told the Board that they had done this in other Counties and would be willing to do this in this situation under the understanding that the Board still approves everything that is rented and understands it is still ultimately a county building. Charles Sifers A.D.A. stated that he would like to see and MOU written between the two entities. The Health Department agreed that they could get that written up and bring back before the Board.
