Minutes of the County Commissioners Regular meeting held on August 21, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the August 14, 2023 meeting. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Mr. Spellman from Grady Memorial Hospital was in attendance to explain to the Commissioners the reason he is asking for \$813,092.00. It is due to insurance coverage expense to the hospital. The Commissioners agreed that they should be helping the hospital and want to pay this out on the schedule given to them by Mr. Spellman. Commissioner Davis stated that this money will be coming from our Contingency fund and that we will need to make this a one-time expenditure due to emergency expenditures that keep coming up with buildings in the County.

Kirk Painter made a motion to approve to cover Property Insurance Capital call expenses related to Grady Memorial Hospital's mandatory insurance coverage in the amount of \$813,092.00 is due soon. The Commissioners want to pay this amount by the schedule that was presented to the Board at the meeting. It was seconded by Zachary Daivs. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve the nomination of Brad Wilkerson for the Grady Memorial Hospital Advisory Board representing Grady County District 3. (Note: Agenda stated District 2 but due to redistricting it is now District 3 – Scrivener's Error). It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

GCEMA/Fire Report/Safety Director: Dale Thompson informed the Board that they would be participating in a functional exercise with Iron Horse Midstream in Amber on Thursday from 8:00-1:00. Dale asked Commissioner Davis if they could mow one of the repeaters in Minco. The Tuttle Emergency Manager, Mike Fay was concerned that driving in there could cause a fire hazard. Kim Duke reported that the Fire Board meeting was Tuesday night and she would be receiving the minutes and sending them to the Commissioners. Kim stated that she would be working at the Grady County Fire Fair booth at the end of the week and Grady County Fire has been asked to help at the tractor pull this year. Bobby Cantu informed the Commissioners that he would be doing the Corporation Commission Fuel Leak Tank Inspections and Fire Extinguisher Inspections for the County this week and a Safety meeting with the Assessor's office.

Public Comments: Mr. Pat Ronch with P & K Equipment was present. Mr. Shon Richardson was present representing CEC and introduced his dad Mr. Johnny Richardson.

New Business: Commissioner Davis addressed the Board about P-cards, he said the CED meeting that he just attended had information on the P-card and how hotels are going to stop taking Purchase Orders and only accept P-cards. He asked the County Clerks to do some research on this. The Purchasing Agent said she would like to come and speak to the Board on this in the next meeting.

Commissioner Bray stated that Charlie Burrus wrote a letter declining the position of serving on the Grady County Criminal Justice Authority Board. He said that he did have another candidate and would put this person on the agenda for next week.

Vicki Elliott asked the Board if they wanted to advertise for a new janitor and Commissioner Davis responded with saying that he felt like we should see about using a Temporary Employment Agency. The Board agreed to try the Temporary Employment Agency.

Kayla Jarrett was in attendance for the Grady County Health Department, she gave information to the Commissioners on what she researched about the two different vendors and told them that Heritage Hills Construction is who they would prefer.

Zachary Davis made a motion to approve the tabled item for Grady County paying for repairs needed to the roof of the building located at 205 West Chickasha Avenue. The vendor they will be using is Heritage Hills Construction in the amount of \$8,637.44. Pads will be installed by the maintenance department. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve a contract for X-ray services between Grady County Health Department and Grady Memorial Hospital. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

Kirk Painter made a motion to approve Able Movers to move files from the attic to the 3rd floor and to pay for it out of Court Preservation. The quote that was presented was for 2-men \$120.00 per hour or 3-men \$145.00 per hour. It was seconded by Zachary Davis. AYE: Kirk Painter, Gary Bray, and Zachary Davis.
