

**GRADY COUNTY, OKLAHOMA PERMIT APPLICATION**

**FASTLINE/ABOVE GROUND LINES**

**PUBLIC/ PRIVATE ENCROACHMENT, OR WORK ON OR WITHIN COUNTY  
HIGHWAY SYSTEM OR RIGHT OF WAY**

The undersigned, hereby petitions the Board of County Commissioners of Grady County, Oklahoma to grant a permit for a fastline/above ground line along a County highway or other public way as described below and in accordance with the provisions listed herein. **Fee of \$3000.00 per Application for Permit along with a copy of liability insurance unless waived by the Board of Commissioners. Fee must be received before application is approved. Make all checks out to Grady County Commissioners. All permits must be returned to 326 W. Choctaw Chickasha, Ok 73018**

A **plat or map** must be attached clearly illustrating where the work is to be performed. The map/plat must show the entire length of installation.

**NO PIPELINES OR TELECOMMUNICATION LINES EXCEPT FOR PUBLIC UTILITIES SHALL BE PLACED IN COUNTY RIGHT-OF-WAY. NO INGRESS/EGRESS SHALL BE MADE FROM COUNTY ROADWAY WITHOUT THIS PERMIT OR OTHER APPROVAL OF THE BOARD OF COUNTY COMMISSIONERS.**

**COMPANIES SECURING A PERMIT SHALL HAVE LIABILITY INSURANCE AND SHALL ABIDE BY ALL THE TERMS OF THIS PERMIT INCLUDING LIABILITY FOR DAMAGE TO GRADY COUNTY ROADS AND BRIDGES. INCLUDE INSURANCE WITH THIS PERMIT**

If granted, this permit is subject to the following conditions, requirements, and covenants, to wit:

The applicant agrees to hold Grady County harmless for any damage or injury to persons or property caused by or resulting from the construction, maintenance, operation, or repair of the facilities on, under, or over the county right-of-way. The petitioner/contractor will be responsible for any damage resulting from deviation of the plat, or violation of the terms of this permit.

The petitioner/contractor shall furnish all flagmen, lights, barricades, and warning signs meeting all laws and regulations, including those in the "Manual on Uniform Traffic Control Devices" appropriate for the construction project and/or signage otherwise required by ODOT. The petitioner/contractor agrees to keep the roadway open to traffic and in clean condition throughout the course of construction unless otherwise approved by the Board of County Commissioners. At the conclusion of such work, the right-of-way must be cleaned up and left in as good or better condition than upon Applicant's arrival.

The contractor shall not use temporary lines for pumping any kind of used fluids salt water or petroleum products.



Requirements:

- a) Above ground water lines running parallel with a county road and temporary SHALL be placed within 3' feet of the fence line, or the outer edge of the Right-of-Way, as not to disrupt road maintenance.
- b) All temporary lines SHALL be marked every ½ mile with contractor name, phone number and date of installation. The sign or label shall be a minimum dimension of 130 square inches and erected at a height plainly visible from the road.
- c) Water pumps shall NOT be on the Right-of-Way. Pipe Reels or spools shall not be left or stored on the Right-of-Way.
- d) All temporary lines or combination of lines going through culverts shall not be more than 50% of the culvert.
- e) Any line interfering with road maintenance will be removed. The owner, firm or company shall be responsible for all damages to the county roads due to a line or multiple lines running along road way or through culvert, which reduces the drainage capacity.
- f) Temporary, non-buried lines shall not be place in the Right-of-Ways except as allowed herein.

**Owners of all facilities shall be responsible, at their expense, for decommissioning of sites. Roads and right-of-way shall be restored to the original condition or better.**

The granting of this easement does not take into consideration whether or not the adjoining property owner is entitled to compensation for the easement being placed in the county road right-of- way.

- Above ground water lines running parallel with a county road and temporary SHALL be placed within 3' feet of the fence line, or the outer edge of the Right-of-Way, as not to disrupt road maintenance.
- All temporary lines SHALL be marked every ½ mile with contractor name, phone number and date of installation. The sign or label shall be a minimum dimension of 130 square inches and erected at a height plainly visible from the road.
- Water pumps shall NOT be on the Right-of-Way. Pipe Reels or spools shall not be left or stored on the Right-of-Way.

- Request for Deviation from Permit Terms - If Applicant requests deviation from the provisions set out in this Permit, the Application shall be set on the Agenda of the Board of County Commissioners for determination whether deviation should be granted, and what fee and/or bond shall be set, if any.
