Minutes of the County Commissioners Regular meeting held on October 10, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the October 2, 2023 meeting. It was seconded by Zachary Davis. AYE: Kirk Painter and Zachary Davis. Gary Bray abstained.

GCEMA/Fire Report/Safety Director: Kim Duke reported that they completed their 4th CPR class at Alex last Saturday.

New Business: Sabra Martin asked Commissioner Bray if he could mow some of the area around the Pioneer School, specifically the railroad track area. She said there has been many sightings of people walking on the railroad tracks and since it was so close to the school, they felt like cleaning it up would help get a better visual. The Commissioners told her they are not allowed to mow on the rail road tracks, they would have to get in contact with the railroad. Commissioner Bray asked if we could put the USDA trapper Rick Menefee on the agenda for next week and get a contract signed for him to come in and help with some of the wild animal control problems they are having in his area. Commissioner Painter spoke to the Board about the robberies that they had the Monday night at Highway 81 businesses. Commissioner Painter informed the Board that there was going to be a ground breaking ceremony take place in the afternoon at 3:00 for the new secure Sally Port that the jail was building.
