## Minutes of the County Commissioners Regular meeting held on October 2, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Doug Chaney, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Doug Chaney, and Zachary Davis. Gary Bray was absent.

The meeting was opened with the "Pledge of Allegiance"

These classes can be for Grady County employees or other county employees that need this training. Bobby Cantu reported that K & M Safety has almost completed the annual Safety Inspections for the County and Bobby has completed his Quarterly inspections as well. He stated that Native Striping was here over the weekend completed the striping for the new handicap parking.
