Minutes of the County Commissioners Regular meeting held on October 23, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the October 16, 2023 meeting. It was seconded by Gary Bray. AYE: Kirk Painter, Gary Bray, and Zachary Davis.

GCEMA/Fire Report/Safety Director: Dale informed the Commissioners that the LEPC meeting last week went well and there is a meeting with Nomad Communications this week to talk about the new communications van. Dale stated that the van should be here November 9th and then he will be taking it to Stolz to install equipment that had been taken off the previous communications unit. Kim Duke stated that there was no Fire Board meeting last week due to the agenda not being posted in time. Bobby Cantu reported that he would be doing all his monthly inspections this week and that the concrete for the Election Board was not poured due to an illness but would be poured this week. Bobby gave the Board information he heard at the ACCO Safety Conference about new Drug Testing using saliva instead of urine. Mike McDaniel the new Construction Superintendent reported that he has been in contact with someone to remove a tree from the front of the Courthouse, has ordered a door for the Election Board that they were having problems with, and he has started some concrete projects.

Public Comments: Michael Westfall with Auto Zone was in attendance to inform the Commissioners that Auto Zone is now set up with State Contract and can help with any of the County needs.

New Business: Commissioner Davis stated that Charles Sifers, ADA contacted him about pledging the Opioid Abatement funds to start a rehab facility for Grady County and include surrounding areas. The ADA was clear that voting in new business was the way to handle this because of a timing issue.
