Minutes of the County Commissioners Regular meeting held on November 13, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

Kirk Painter made a motion to approve the minutes of the November 6, 2023 meeting. It was seconded by Gary Bray. AYE: Kirk Painter and Gary Bray. Zachary Davis abstained.

GCEMA/Fire Report/Safety Director: Dale reported that he would be doing the final walk through for the Communications unit by video this week and the unit will be delivered to Oklahoma City on Thursday. He stated that he will be attending the Medical Response Surge Exercise on Tuesday and State training Committee meeting on Friday. Bobby Cantu informed the Board that there was one reportable injury this week for Grady County. He stated that he would be conducting safety meetings this week and working on updating the Disaster Recovery plans. He reported to the Board that he did a work site inspection with District 2 and he was happy to report everything was good. Mike McDaniel stated that he spoke to the City of Chickasha about the sink hole in the alley way by the Health Dept. building and they are working to fix the issue. He reported that the speed bumps ordered will need a storage place until they have been installed. The Sheriff stated that they can leave them at his parking lot until they are installed. Richard Stark who is the architect for the plumbing and electrical update for the Courthouse was in attendance and spoke to the Board. He stated that there were two ways to go about fixing the plumbing issues; one would be demolition in Judge Young's Courtroom and the other would be to demo the hallway in the basement and lay new lines. He said there would also be some updating of the bathrooms but all the lines are in the basement floor. He gave them some renovation updates for the electrical update as well. The Commissioners said they felt like the hallway would be the best option, but would like to put it on the agenda for next week.

New Business: The Sheriff stated that the process for the closing for the land across from the Sheriff's office is starting on November 20, 2023. Bobby Cantu stated that the County needs to figure out where there would be storage for the Court Clerk records. Bobby stated that the Health Department does not have enough room for all the records that are still upstairs.
