Minutes of the County Commissioners Regular meeting held on November 6, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter and Gary Bray. Zachary Davis was absent.

The meeting was called to order and roll call: Kirk Painter and Gary Bray. Zachary Davis was absent.

The meeting was opened with the "Pledge of Allegiance"

GCEMA/Fire Report/Safety Director: Kim Duke informed the Commissioners there was an EDT class on the 4th of November and the State EMR inspections will be conducted this week. Bobby stated that the Construction Engineer should be finished with the Blue-Prints by mid-November. He said that he has set up the LTAP classes for January 17th and 18th, 2024 and the Department of Labor should be doing their 2-year inspection soon. Mike McDaniel spoke to the Board about the Health Department contacting him about the County fixing the alley way and the Commissioners stated they would like for them to check with the City of Chickasha since the alley is considered city property. Mike stated that they would be installing the speed bumps in the parking lot of the Courthouse this week.

New Business: Mike McDaniel spoke about the Naples Fire Station; he said that the current plan needs to be addressed about the building they are wanting. It will not match the ARPA grant they received and wants to know how to proceed. The Commissioners stated they should talk with Floyd and Driver and see if we should do an amendment to the ARPA grant. Mike stated that the deputies in the Courthouse contacted him about the lighting in the parking lot. The Commissioners told him that they may need to get in contact with an electrician and see about getting their advice on how to light the parking lot up better.
