## Minutes of the County Commissioners Regular meeting held on December 4, 2023

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was called to order and roll call: Kirk Painter, Gary Bray, and Zachary Davis.

The meeting was opened with the "Pledge of Allegiance"

GCEMA/Fire Report/Safety Director: Kim Duke reported that the OERB training went well last week in Tulsa. She stated that she has the annual scheduled meeting list done and is sending it out to the Board for their approval. Bobby Cantu informed the Board that the Hot Water Tank Inspections are scheduled for the 6<sup>th</sup> or 7<sup>th</sup> of December. Bobby stated that he is finishing the Safety Meetings and will have them done by the end of the year. Mike McDaniels stated that he installed the speed bumps last weekend in the Courthouse parking lot. The lights for the parking lot at the Courthouse are scheduled for this weekend, they are waiting on parts. He also told the Board that the City of Chickasha has been in contact with him and they are bringing in a specialist to work on the sink hole in the alley behind the Health Department.
