Minutes of the County Commissioners Regular meeting held on January 8, 2024

The Board of the Grady County Commissioners met on this day for a regularly scheduled meeting with the following board members: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was called to order and roll call: Zachary Davis, Kirk Painter, and Gary Bray.

The meeting was opened with the "Pledge of Allegiance"

Zachary Davis made a motion to approve the minutes of the January 2, 2024 meeting. It was seconded by Gary Bray. AYE: Zachary Davis, Kirk Painter, and Gary Bray.

GCEMA/Fire Report/Safety Director/Superintendent: Kim Duke informed the Commissioners that she would be sending out the minutes from the last Board meeting soon. Bobby Cantu reported that he completed the cost management with FEMA and District 1 and 2 would be splitting the amount of \$3,397.30 when the check is received into the County funds. He stated that he would be attending the ACCO quarterly Safety Seminar on the 10th and 11th of this week. Mike McDaniels reported that the stairs in the basement at the DA's office have been installed as well as the backflush valve and the safety ladder to the roof of the Emergency Management/Election Board building will be lifted at a safe level sometime this week.

New Business: Commissioner Bray had some concerns of our application stating that you could not be related to anyone in the County if you applied at the County. The Commissioners agreed that the Nepotism law only applied to the Elected Official that you would be working under. Jill Locke suggested that the County revise the employment application.
